UNILATERAL CONTACT OF ELASTIC BODIES (MOMENT THEORY)

ABSTRACT. Boundary contact problems of statics of the moment (couplestress) theory of elasticity are studied in the case of a unilateral contact of two elastic anisotropic nonhomogeneous media. A problem, in which during deformation the contact zone lies within the boundaries of some domain, and a problem, in which the contact zone can extend, are given a separate treatment. Concrete problems suitable for numerical realizations are considered.

The theory of variational inequalities is one of the most successful methods used to investigate problems of the unilateral contact of elastic bodies. In this paper, using the general theory of variational inequalities, we study the unilateral contact of two anisotropic nonhomogeneous elastic bodies in the moment theory of elasticity. We also study questions of the existence and uniqueness of a weak solution and consider concrete problems suitable for numerical realizations. A problem in which the contact zone lies within some domain and a problem in which the contact zone extends are treated separately.

I. A PROBLEM WITH A BOUNDED CONTACT ZONE

Let $\Omega_q \subset \mathbb{R}^3$ (q=1,2) be the contacting bounded domains with Lipshitz piecewise smooth boundaries filled up with different elastic materials. The basic equations of statics of the couple-stress theory of elasticity for anisotropic nonhomogeneous elastic media theory can be written in terms of stress components as follows (see [1]):

where ε_{ikj} is the Levy-Cività symbol, $F^{(q)}:\Omega_q\to\mathbb{R}^3$ is mass force, $G^{(q)}:\Omega_q\to\mathbb{R}^3$ is mass moment; $\sigma_{ij}^{(q)},\mu_{ij}^{(q)}:\Omega_q\to\mathbb{R}$, where

is the stress force tensor, and

is the moment stress tensor (here and in what follows the repetition of the symbol without brackets means summation over this index from 1 to 3),

are strain components, $\omega_{lk}^{(q)}(x) = \partial \omega_k^{(q)}(x)/\partial x_l$ are torsion-bending components, $u^{(q)}: \Omega_q \to \mathbb{R}^3$ is the displacement vector, $\omega^{(q)}: \Omega_q \to \mathbb{R}^3$ is the rotation vector, and the real-valued functions $a_{ijlk}^{(q)}, b_{ijlk}^{(q)}, c_{ijlk}^{(q)}$ (called the elastic constants) belong to the class $C^1(\overline{\Omega}_q)$ and satisfy the usual requirements for symmetry and ellipticity, i.e., $a_{ijlk}^{(q)} = a_{lkij}^{(q)}, \quad c_{ijlk}^{(q)} = c_{lkij}^{(q)}, \quad q = 1, 2$, and there exists $\alpha_0 > 0$ such that

for all $x \in \overline{\Omega}_q$ and $\xi_{ij}, \eta_{ij} \in \mathbb{R}$.

Let $n^{(q)}(x)$, q=1,2 be the unit normal at a point x of the surface $\partial\Omega_q$ which is external with respect to $\Omega^{(q)}$, and $\mathcal{M}(x,\partial)$ be the 6×6 matrix differential operator of statics of the couple-stress theory of elasticity which corresponds to system (1) (see [2], [3]), and $\mathcal{N}(x,\partial,n^{(q)})$ be the 6×6 matrix differential stress operator (see [2], [3]). Clearly, in such notation, system (1) takes the form

where $\mathcal{U}^{(q)} = (u^{(q)}, \omega^{(q)})$ and $\mathcal{F}^{(q)} = (F^{(q)}, G^{(q)})$.

We will use the following notation:

The total strain energy of the respective media has the form

Let us assume that Γ_u , Γ_0 , Γ_c and $\Gamma_T^{(q)}$ are pairwise nonintersecting smooth open subsurfaces of the boundary $\partial\Omega_1 \cup \partial\Omega_2$; $(\partial\Omega_1 \cap \partial\Omega_2 = \Gamma_c)$, while $\partial\Omega_1 = \overline{\Gamma}_u \cup \overline{\Gamma}_T^{(1)} \cup \Gamma_c$, $\partial\Omega_2 = \overline{\Gamma}_0 \cup \overline{\Gamma}_T^{(2)} \cup \Gamma_c$ and Γ_c and Γ_u have a positive measure. Let $(v)_n$ and $(v)_t$ denote the normal and the tangential component of the vector $v \in \mathbb{R}^3$, respectively. Below we will use the spaces $H^s(\Omega_q)$ and $H^s(\partial\Omega_q)$, $s \in \mathbb{R}$, whose definitions and main properties can be found in [4], [5].

Definition 1. A vector function $\mathcal{U}^{(q)} \in (H^1(\Omega_q))^6$ is called a weak solution of equation (3) for $\mathcal{F}^{(q)} \in (L_2(\Omega_q))^6$ if $\mathcal{B}^{(q)}(\mathcal{U}^{(q)}, \Phi) = (\mathcal{F}^{(q)}, \Phi)_{0,\Omega_q}, \quad \forall \Phi \in (C_0^{\infty}(\Omega_q))^6$, where as usual

Note that if $\mathcal{U}^{(q)} \in (H^1(\Omega_q))^6$ and $\mathcal{M}\mathcal{U}^{(q)} \in (L_2(\Omega_q))^6$, then $\mathcal{N}\mathcal{U}^{(q)}|_{\partial\Omega_q}$ can be defined as an element of the space $(H^{-1/2}(\partial\Omega_q))^6$ by using the relations:

which take place for all $\Phi \in (H^{1/2}(\partial\Omega_q))^6$; here and in what follows the symbol $\langle .,. \rangle$ denotes the duality relation between the corresponding dual spaces.

Let us introduce the space

We will consider the following boundary-contact problem.

Problem 1. Find a vector function $\mathcal{U}^{(q)} = (u^{(q)}, w^{(q)}) \in (H^1(\Omega_q))^6$ which is a weak solution of equation (3) and satisfies the conditions

where $n^{(2)} = -n^{(1)}$ on Γ_c , $\mathcal{F}^{(q)} \in (L_2(\Omega_q))^6$ and $\mathcal{P}^{(q)} \in (H^{-1/2}(\partial \Omega_q))^6$ such that $\langle \mathcal{P}^{(q)}, \Phi \rangle_{\partial \Omega_q} = 0$, $\forall \Phi \in (H^{1/2}(\partial \Omega_q))^6$, $\Phi \Big|_{\overline{\Gamma}_T^{(q)}} = 0$.

A similar problem in the classical theory of elasticity is considered in [6]. Let us introduce the following notation:

It is easy to prove that $\mathcal{U} \in \mathcal{K}$ minimizes the functional \mathcal{L} on the convex closed set \mathcal{K} if and only if

Definition 2. We call a vector function $\mathcal{U} \in \mathcal{K}$ a variational solution of Problem 1 if the variational inequality (8) is fulfilled.

Proposition 1. Each solution of Problem 1 is a variational one and vice versa.

Proof. Let $\mathcal{U} \in \mathcal{H}^1(\Omega)$ be a solution of Problem 1. By virtue of the internal regularization theorems (see [7]) we have $\mathcal{U} \in \mathcal{H}^2_{loc}(\Omega)$ and (3) holds. Now, applying the Green's formula,

Since \mathcal{U} is a solution of Problem 1 and $\mathcal{V} \in V$, the duality relation on Γ_0 is equal to zero, whereas the last term of the equality gives

by virtue of the contact conditions of Problem 1.

Thus eventually we obtain

Let $W \in \mathcal{K}$, $W = (W^{(1)}, W^{(2)})$, $W^{(q)} = (\varphi^{(q)}, \psi^{(q)})$. Then $\mathcal{V} = W - \mathcal{U} \in V$ and, by virtue of conditions $(7)_2$, we have $(\overset{(1)}{\sigma}\mathcal{U}^{(1)})_{n^{(1)}} = 0$ at the points Γ_c where $u^{(1)} \cdot n^{(1)} + u^{(2)} \cdot n^{(2)} < 0$ whereas the inequality

is fulfilled if $u^{(1)} \cdot n^{(1)} + u^{(2)}n^{(2)} = 0$.

Thus $\left\langle {\binom{(1)}{\sigma} \mathcal{U}^{(1)}}_{n^{(1)}} \right|_{\Gamma_c}$, $v^{(1)} \cdot n^{(1)} + v^{(2)} \cdot n^{(2)} \right\rangle_{\Gamma_c} \ge 0$ and therefore $\forall \mathcal{W} \in \mathcal{K} : \mathcal{B}(\mathcal{U}, \mathcal{W} - \mathcal{U}) - L(\mathcal{W} - \mathcal{U}) \ge 0$.

Conversely, let now $\mathcal{U} \in \mathcal{K}$ be a solution of the variational inequality (8). After replacing in (8) $\mathcal{U}^{(q)} \pm \Phi^{(q)}$ by $\mathcal{V}^{(q)}$, where $\Phi^{(q)} \in (C_0^{\infty}(\Omega_q))^6$, we obtain

On replacing in (9) $\mathcal{U}^{(q)} \pm \Phi^{(q)}$ by $\mathcal{V}^{(q)}$, where $\Phi^{(q)} \in (C^{\infty}(\Omega_q))^6$ is such that supp $\Phi^{(q)}|_{\partial\Omega_q} \subset \Gamma_T^{(q)}$, we have $\langle \mathcal{N}\mathcal{U} - \mathcal{P}, \Phi \rangle_{\Gamma_T^{(1)} \cup \Gamma_T^{(2)}} = 0$.

This gives us (6). Condition (4) and the first conditions of (5), (7)₁ and (7)₄ are fulfilled automatically since $\mathcal{U} \in \mathcal{K}$.

Let us now replace in (9) \mathcal{V} by $\mathcal{U} \pm \Phi$, where $\Phi = (\Phi^{(1)}, \Phi^{(2)}) \in (C_0^{\infty}(\Omega_1))^6 \times (C^{\infty}(\Omega_2))^6$ is such that $\Phi^{(q)} = (\varphi^{(q)}, \psi^{(q)})$, supp $\Phi^{(2)}\Big|_{\partial\Omega_2} \subset \Gamma_0$, $\psi^{(2)}\Big|_{\Gamma_0} = 0$ and $\varphi^{(2)} \cdot n^{(2)}\Big|_{\Gamma_0} = 0$. Then $\left\langle {2 \choose \sigma \mathcal{U}^{(2)}_{t^{(2)}}}\Big|_{\Gamma_0}, (\varphi^{(2)}_{t^{(2)}})\right\rangle_{\Gamma_0} = 0$. Hence because of the arbitrariness of $(\varphi^{(2)}_{t^{(2)}})_{t^{(2)}}$ it follows that $(\varphi^{(2)}_{t^{(2)}})_{t^{(2)}}\Big|_{\Gamma_0} = 0$.

In a similar manner we conclude that the condition $\binom{2}{\mu}\mathcal{U}^{(2)}_{t^{(2)}}\Big|_{\Gamma_0} = 0$ is fulfilled on Γ_0 .

The above reasoning enables us to rewrite (9) as

$$\sum_{q=1}^{2} \left\langle (\stackrel{(q)}{\mathcal{N}} \mathcal{U}^{(q)}) \right|_{\Gamma_c}, \mathcal{V}^{(q)} - \mathcal{U}^{(q)} \right\rangle_{\Gamma_c} \ge 0. \tag{10}$$

Choose $\mathcal{V} = \mathcal{U} \pm \Phi$ such that $\Phi = (\Phi^{(1)}, \Phi^{(2)}) \in \mathcal{H}^1(\Omega)$, supp $\Phi^{(q)}\Big|_{\partial\Omega_q} \subset \overline{\Gamma}_c$, $\Phi^{(q)} = (\varphi^{(q)}, \psi^{(q)})$, $\psi^{(1)}\Big|_{\Gamma_c} = \psi^{(2)}\Big|_{\Gamma_c} = (\varphi^{(1)})_{t^{(1)}}\Big|_{\Gamma_c} = (\varphi^{(2)})_{t^{(2)}}\Big|_{\Gamma_c} = 0$, and $\varphi^{(1)} \cdot n^{(1)}\Big|_{\Gamma_c} = -\varphi^{(2)} \cdot n^{(2)}\Big|_{\Gamma_c} = \psi$, where $\psi \in \widetilde{H}^{1/2}(\Gamma_c)$. Then

$$\left\langle \binom{\binom{1}{\sigma}\mathcal{U}^{(1)}}{n^{(1)}}\right|_{\Gamma_c} - \binom{\binom{2}{\sigma}\mathcal{U}^{(2)}}{n^{(2)}}\Big|_{\Gamma_c}, \psi\right\rangle_{\Gamma_c} = 0, \quad \forall \, \psi \in \widetilde{H}^{1/2}(\Gamma_c),$$

i. e., $\binom{\binom{1}{\sigma}\mathcal{U}^{(1)}}{\binom{n}{\sigma}}\Big|_{\Gamma_c} = \binom{\binom{2}{\sigma}\mathcal{U}^{(2)}}{\binom{n}{\sigma}}\Big|_{\Gamma_c}$. In a similar way we establish condition $(7)_3$ and the second condition of $(7)_4$.

With the above arguments taken into account we can rewrite (10) as follows:

$$\forall \mathcal{V} \in \mathcal{K} : \left\langle \binom{(1)}{\sigma} \mathcal{U}^{(1)} \right\rangle_{n^{(1)}} \left|_{\Gamma_c}, \left((v^{(1)} - u^{(1)}) \cdot n^{(1)} + (v^{(2)} - u^{(2)}) \cdot n^{(2)} \right)_{\Gamma_c} \right\rangle_{\Gamma_c} \ge 0. \tag{11}$$

If we choose $\mathcal{U} = \mathcal{U} + \Phi$, where $\Phi = (\Phi^{(1)}, \Phi^{(2)}) \in \mathcal{H}^1(\Omega)$ is such that $\sup \Phi^{(q)}\Big|_{\partial\Omega_q} \subset \overline{\Gamma}_c$, $\Phi^{(q)} = (\varphi^{(q)}, \psi^{(q)})$, $\psi^{(q)}\Big|_{\Gamma_c} = 0$ and $(\psi^{(1)})_{t^{(1)}}\Big|_{\Gamma_c} = (\varphi^{(2)})_{t^{(2)}}\Big|_{\Gamma_c} = 0$, $\varphi^{(2)} \cdot n^{(2)}\Big|_{\Gamma_c} = 0$ and $\varphi^{(1)} \cdot n^{(1)}\Big|_{\Gamma_c} = \varphi$, where $\varphi \in \widetilde{H}^{1/2}(\Gamma_c)$ is arbitrary with the condition $\varphi \leq 0$, then $\mathcal{V} \in \mathcal{K}$ and $\langle (\overset{(1)}{\sigma}\mathcal{U}^{(1)})_{n^{(1)}}\Big|_{\Gamma_c}, \varphi \rangle_{\Gamma_c} = 0$. Hence $(\overset{(1)}{\sigma}\mathcal{U}^{(1)})_{n^{(1)}}\Big|_{\Gamma_c} \leq 0$ as a distribution of the class $H^{-1/2}(\Gamma_c)$. Therefore the second condition of $(7)_1$ holds.

It remains to prove $(7)_2$.

Since $\mathcal{V} = 0$ and $\mathcal{V} = 2\mathcal{U}$ belongs to the convex closed set \mathcal{K} substituting $\mathcal{V} = 0$ into (11) and then doing the same with $\mathcal{V} = 2\mathcal{U}$, we obtain that (7)₂ is fulfilled everywhere on Γ_c . Proposition 1 is proved. \square

As is known, in the moment theory of elasticity the space of rigid displacement vectors is written as

$$\mathcal{R}^{(q)} = \left\{ (\rho^{(q)}, a^{(q)}) \middle| \rho^{(q)} = [a^{(q)} \times x] + b^{(q)}, a^{(q)}, b^{(q)} \in \mathbb{R}^3, \ q = 1, 2 \right\},$$
 where $[a^{(q)} \times x]_i = \varepsilon_{ijk} a_j^{(q)} x_k; \ \mathcal{R} = \mathcal{R}^{(1)} \times \mathcal{R}^{(2)}.$

It is easy to verify that $\mathcal{B}(\mathcal{U}, \mathcal{V}) = 0$, $\forall \mathcal{U} \in \mathcal{R}$ and $\forall \mathcal{V} \in \mathcal{H}^1(\Omega)$.

The converse is also true: if $\mathcal{U} \in \mathcal{H}^1(\Omega)$ and $\xi_{ij}(\mathcal{U}^{(q)}) = 0$, $\eta_{ij}(\mathcal{U}^{(q)}) = 0$, i, j = 1, 2, 3, then $\mathcal{U} \in \mathcal{R}$.

Let $\mathcal{U} \in \mathcal{K}$ be a variational solution of Problem 1. Then if in (8) \mathcal{V} is replaced by $\mathcal{U} + Y$, where $Y \in \mathcal{K} \cap \mathcal{R}$ (note that $\mathcal{U} + Y \in \mathcal{K}$), then we have $0 = \mathcal{B}(\mathcal{U}, Y) \geq L(Y)$, i. e., the condition

$$L(Y) \le 0, \quad \forall Y \in \mathcal{K} \cap \mathcal{R},$$
 (12)

is the necessary one for the existence of a variational solution of Problem 1.

Lemma 1. Let $V \cap \mathcal{R} = \{0\}$ or $L(Y) \neq 0$, $\forall Y \in V \cap \mathcal{R} \setminus \{0\}$. Then there exists at most one variational solution of Problem 1.

Proof. Assume that $\overset{1}{\mathcal{U}}$ and $\overset{2}{\mathcal{U}}$ are solutions of inequality (8). Then

$$\mathcal{B}(\overset{1}{\mathcal{U}},\overset{2}{\mathcal{U}}-\overset{1}{\mathcal{U}})\geq L(\overset{2}{\mathcal{U}}-\overset{1}{\mathcal{U}}),\ \mathcal{B}(\overset{2}{\mathcal{U}},\overset{1}{\mathcal{U}}-\overset{2}{\mathcal{U}})\geq L(\overset{1}{\mathcal{U}}-\overset{2}{\mathcal{U}}).$$

Hence $\mathcal{B}(\overset{1}{\mathcal{U}}-\overset{2}{\mathcal{U}},\overset{1}{\mathcal{U}}-\overset{2}{\mathcal{U}})\leq 0.$

This condition together with (2) implies that $\xi_{ij}(Y) = 0$, $\eta_{ij}(Y) = 0$, $Y = \stackrel{1}{\mathcal{U}} - \stackrel{2}{\mathcal{U}}$, i, j = 1, 2, 3, i.e., $Y \in V \cap \mathcal{R}$. If by the assumption $V \cap \mathcal{R} = \{0\}$, then Y = 0 and the solution is unique. Let now $Y \in V \cap \mathcal{R} \setminus \{0\}$. Denoting $\stackrel{2}{\mathcal{U}}$ by \mathcal{U} , we can write another arbitrary solution of (8) as $\mathcal{U} + Y$, where $Y \in V \cap \mathcal{R}$. Since the energy functional \mathcal{L} has the same minimal value for the vectors \mathcal{U} and $\mathcal{U} + Y$, we obtain

$$[\mathcal{L}(\mathcal{U}) = \mathcal{L}(\mathcal{U} + Y)] \Longrightarrow [L(\mathcal{U}) = L(\mathcal{U} + Y)] \Longrightarrow L(Y) = 0,$$

which contradicts the condition of the lemma. Therefore Y = 0 and the solution of (8) is unique.

As an example let us consider a plane contact problem, in which Γ_0 consists of segments parallel to the x_1 -axis. In that case

$$V \cap \mathcal{R} = \left\{ Y = (Y^{(1)}, Y^{(2)}) \in \mathcal{H}^1(\Omega) : Y^{(1)} = ((0, 0); 0), Y^{(2)} = ((b_1^{(2)}, 0); 0), b_1^{(2)} \in \mathbb{R} \right\}$$

(it should be noted that in the two-dimensional case the space of rigid displacement vectors has the form

$$\mathcal{R} = \left\{ Y = (Y^{(1)}, Y^{(2)}) \in \mathcal{H}^1(\Omega) : Y^{(q)} = ((b_1^{(q)} + a^{(q)}x_2, b_2^{(q)} - a^{(q)}x_1); a^{(q)}) \right\},\,$$

where $a^{(q)} \in \mathbb{R}$ and $b^{(q)} = (b_1^{(q)}, b_2^{(q)}) \in \mathbb{R}^2, \ q = 1, 2).$

Let us assume that $n_1^{(2)} \geq 0$ throughout Γ_c and $n_1^{(2)}(x) > 0$ for some point $x \in \Gamma_c$. Then it is clear that $\mathcal{K} \cap \mathcal{R} = \{Y \in V \cap \mathcal{R} : b_1^{(2)} \leq 0\}$.

Condition (12), which is necessary for the existence of a variational solution, takes the form

$$U_1^{(2)} \equiv \int_{\Omega_2} F_1^{(2)} dx + \left\langle \mathcal{P}_1^{(2)}, 1 \right\rangle_{\Gamma_T^{(2)}} \ge 0.$$

By virtue of Lemma 1, if $U_1^{(2)} \neq 0$, then there exists at most one solution of inequality (8) (indeed, $\forall Y \in V \cap \mathcal{R} \setminus \{0\}$, $L(Y) = b_1^{(2)} U_1^{(2)}$, $b_1^{(2)} \neq 0$, and if $U_1^{(2)} \neq 0$, then we have $L(Y) \neq 0$).

To obtain a general result of the existence of a variational solution of Problem 1, we have to introduce the set of "bilateral" rigid displacement vectors

$$\mathcal{R}^* = \left\{ Y \in \mathcal{K} \cap \mathcal{R} : Y^{(1)} = (0; 0), Y^{(2)} = (b^{(2)}; 0), \ b^{(2)} \in \mathbb{R}^3, \ 0 \in \mathbb{R}^3, \\ b^{(2)} \cdot n^{(2)} \Big|_{\Gamma_0} = b^{(2)} \cdot n^{(2)} \Big|_{\Gamma_c} = 0 \right\}.$$

The next theorem is an immediate corollary of Fichera's theorem on the existence of solutions of abstract variational inequalities (see [7], Theorem 1.II).

Theorem 1. Let $L(Y) \le 0$, $\forall Y \in \mathcal{K} \cap \mathcal{R}$. If this condition is fulfilled in a strong sense, i.e., if the equality sign holds if and only if $Y \in \mathcal{R}^*$, then there exists a variational solution $\mathcal{U} \in \mathcal{K}$ of Problem 1. Any other solution has the form $\mathcal{U} + Y$, where $Y \in V \cap \mathcal{R}$ is such that $\mathcal{U} + Y \in \mathcal{K}$ and L(Y) = 0.

We will prove

Theorem 2. Let

$$V \cap \mathcal{R} = \mathcal{R}_V, \quad \mathcal{K} \cap \mathcal{R} = \mathcal{R}_V,$$
 (13)

$$L(Y) = 0, \quad \forall Y \in \mathcal{R}_V$$
 (14)

and $V = \mathcal{R}_V \oplus H$.

Then there exists a unique solution $\hat{\mathcal{U}} \in \hat{\mathcal{K}} = \mathcal{K} \cap \mathcal{H}$ of the problem

$$\mathcal{L}(\widehat{\mathcal{U}}) \le \mathcal{L}(\mathcal{Z}), \quad \forall \, \mathcal{Z} \in \widehat{\mathcal{K}},$$
 (15)

and each variational solution of Problem 1 can be represented as $\mathcal{U} = \hat{\mathcal{U}} + Y$, $Y \in \mathcal{R}_V$.

If $\widehat{\mathcal{U}} \in \widehat{\mathcal{K}}$ is a solution of problem (15), then $\mathcal{U} = \widehat{\mathcal{U}} + Y$, where Y is any element from \mathcal{R}_V , is a variational solution of Problem 1.

Proof. We begin by remarking that, in the case of a spatial problem, condition (13) is fulfilled if and only if Γ_0 is not a part of the plane (a part of the straight line in the two-dimensional case) or Γ_0 and Γ_c are parallel plane subsulfaces (parallel segments). In the former case, $\mathcal{R}_V = \{0\}$ and condition (14) is fulfilled automatically, whereas in the latter case it holds if and only if $U_1^{(2)} = U_2^{(2)} = 0$, where

$$U_j^{(2)} = \int_{\Omega_2} F_j^{(2)} dx + \left\langle \mathcal{P}_j^{(2)}, 1 \right\rangle_{\Gamma_T^{(2)}}, \quad j = 1, 2.$$

Let $H = V \ominus \mathcal{R}_V$, and the P_H be the operator of orthogonal projection (in the sense of \mathcal{H}^1) of the space V onto H. Using the second Korn inequality in the moment theory of elasticity (see [8]), we can prove that (see also [9])

$$\forall \, \mathcal{V} \in H : \mathcal{B}(\mathcal{V}, \mathcal{V}) \ge c_0 \|P_H \mathcal{V}\|_{1,\Omega}^2 = c_0 \|\mathcal{V}\|_{1,\Omega}^2, \tag{16}$$

where

$$\|\mathcal{V}\|_{1,\Omega}^2 = \sum_{q=1}^2 \|\mathcal{V}^{(q)}\|_{1,\Omega_q}^2.$$

Hence we have

$$\mathcal{L}(\mathcal{V}) = \frac{1}{2}\mathcal{B}(\mathcal{V}, \mathcal{V}) - L(\mathcal{V}) \ge \frac{c_0}{2} \|\mathcal{V}\|_{1,\Omega}^2 - \|L\| \|\mathcal{V}\|_{1,\Omega}, \ \forall \, \mathcal{V} \in H.$$

This proves the coercivity of the functional \mathcal{L} on H.

Therefore problem (15) has a solution since \mathcal{L} is a convex coercive functional on the convex closed set $\widehat{\mathcal{K}} = \mathcal{K} \cap H$. Let $\stackrel{1}{\mathcal{U}}$ and $\stackrel{2}{\mathcal{U}}$ be such two solutions. Then $\mathcal{Z} = \stackrel{1}{\mathcal{U}} - \stackrel{2}{\mathcal{U}} \in \mathcal{R}_V \cap H$, i. e., the solution is unique.

By (14) we have

$$\mathcal{L}(\mathcal{V}) = \mathcal{L}(\mathcal{V} + Y), \quad \forall Y \in \mathcal{R}_V.$$
 (17)

Moreover, we can prove that

$$P_H(\mathcal{K}) = \hat{\mathcal{K}}.\tag{18}$$

Let now \mathcal{U} be a variational solution of Problem (1). By (14)

$$\mathcal{L}(P_H \mathcal{V}) = \mathcal{L}(P_H \mathcal{V} + P_{\mathcal{R}_V} \mathcal{V}) \mathcal{L}(\mathcal{V}), \ \forall \mathcal{V} \in V.$$

Since by (18) $P_H \mathcal{U} \in \mathcal{K}$ and $\mathcal{L}(P_H \mathcal{U}) = \mathcal{L}(\mathcal{U}) \leq \mathcal{L}(\mathcal{V}) = \mathcal{L}(P_H \mathcal{V})$, $\forall \mathcal{V} \in \mathcal{K}$, we conclude with (18) taken into account that $P_H \mathcal{U}$ is a solution of problem (15).

Since we have already shown that problem (15) has a unique solution, we have $P_H \mathcal{U} = \hat{\mathcal{U}}$ and the representation $\mathcal{U} = \hat{\mathcal{U}} + Y$, $Y \in \mathcal{R}_V$ is obvious.

Conversely, let $\mathcal{U} = \hat{\mathcal{U}} + Y$, where $\hat{\mathcal{U}}$ is a solution of problem (15), and $Y \in \mathcal{R}_V$. Since $\mathcal{R}^* = \mathcal{R}_V$, we obtain

$$\begin{aligned} (u^{(1)} \cdot n^{(1)} + u^{(2)} \cdot n^{(2)})\Big|_{\Gamma_c} &= (\widehat{u}^{(1)} \cdot n^{(1)} + \widehat{u}^{(2)} \cdot n^{(2)} + y^{(1)} \cdot n^{(1)} + y^{(2)} \cdot n^{(2)})\Big|_{\Gamma_c} \\ &= (\widehat{u}^{(1)} \cdot n^{(1)} + \widehat{u}^{(2)} \cdot n^{(2)})\Big|_{\Gamma} \le 0 \end{aligned}$$

and therefore $\mathcal{U} \in \mathcal{K}$.

By (17)

$$\mathcal{L}(\mathcal{U}) = \mathcal{L}(\widehat{\mathcal{U}}) \le \mathcal{L}(\mathcal{Z}), \quad \forall \, \mathcal{Z} \in \widehat{\mathcal{K}}.$$
 (19)

Clearly, $P_H \mathcal{V} \in \hat{\mathcal{K}}$, $\forall \mathcal{V} \in \mathcal{K}$, and $\mathcal{L}(\mathcal{V}) = \mathcal{L}(P_H \mathcal{V} + P_{\mathcal{R}_V} \mathcal{V}) = \mathcal{L}(P_H \mathcal{V})$. Hence, by virtue of (19) it follows that $\mathcal{L}(\mathcal{U}) \leq \mathcal{L}(\mathcal{V})$, $\forall \mathcal{V} \in \mathcal{K}$, i. e., \mathcal{U} is a variational solution of Problem 1. \square

The following theorem is true.

Theorem 3. Let

$$\mathcal{R}^* = \{0\} \neq \mathcal{R}_V, \quad L(Y) \neq 0, \quad \forall Y \in \mathcal{R}_V \setminus \{0\}, \tag{20}$$

and either $K \cap R = \{0\}$ or

$$\mathcal{L}(Y) < 0, \quad \forall Y \in \mathcal{K} \cap \mathcal{R} \setminus \{0\}.$$
 (21)

Then \mathcal{L} is coercive on \mathcal{K} and there exists a unique variational solution of Problem 1.

Proof. Assume that $K \cap R = \{0\}$. Then the proof of the theorem immediately follows from the following lemma (see [10]).

Lemma 2. Let a semi-norm $|\cdot|$ be given on the Hilbert space H with norm $\|\cdot\|_H$, and $\mathbb{R} = \{v \in H : |v| = 0\}$ be a finite-dimensional subspace of H. It is assumed that for some $c_i > 0$, i = 1, 2,

$$c_1 \|u\|_H \le |u| + \|P_{\mathbb{R}}u\|_H \le c_2 \|u\|_H, \quad \forall u \in H,$$
 (22)

where $P_{\mathbb{R}}$ is the operator of orthogonal (in the sense of H) projection onto \mathbb{R} . K is a convex closed subset of H such that $K \cap \mathcal{R} = \{0\}$, and $\beta : H \to \mathbb{R}^1$ is the penalty functional for which $\ker \beta = K$ and

$$D\beta(tu, v) = tD\beta(u, v), \quad \forall t > 0, \quad \forall u, v \in H, \tag{23}$$

where D is the Gateaux differential.

Then

$$|u|^2 + \beta(u) \ge c||u||_H^2, \quad \forall u \in H.$$
 (24)

In our case, assuming that H = V, $\mathbb{R} = V \cap \mathcal{R} = \mathcal{R}_V$, we have

$$|\mathcal{V}| = \sum_{q=1}^{2} \int_{\Omega_{q}} \left[\xi_{ij}(\mathcal{V}^{(q)}) \xi_{ij}(\mathcal{V}^{(q)}) + \eta_{ij}(\mathcal{V}^{(q)}) \eta_{ij}(\mathcal{V}^{(q)}) \right] dx$$

and

$$\beta(\mathcal{V}) = \int_{\Gamma_s} \left[(v^{(1)} \cdot n^{(1)} + v^{(2)} \cdot n^{(2)})^+ \right]^2 ds,$$

where $\varphi^+ = \min(\varphi, 0)$.

To check (22) we have to use the decomposition $V = \mathcal{R}_V \oplus Q$ and inequality (16). We have

$$\|\mathcal{V}\|_{1,\Omega}^{2} = \|P_{Q}\mathcal{V}\|_{1,\Omega}^{2} + \|P_{\mathcal{R}_{V}}\mathcal{V}\|_{1,\Omega}^{2} \le c|P_{Q}\mathcal{V}|^{2} + \|P_{\mathcal{R}_{V}}\mathcal{V}\|_{1,\Omega}^{2}$$
$$= c|\mathcal{V}|^{2} + \|P_{\mathcal{R}_{V}}\mathcal{V}\|_{1,\Omega}^{2}, \quad \forall \mathcal{V} \in V,$$

which gives the left-hand side of inequality (22). The right-hand side is obvious. It is also easy to check the fulfilment of (23) and $\ker \beta = \mathcal{K}$. Now it is clear that (24) implies that $|\mathcal{V}|^2 \geq c ||\mathcal{V}||_{1,\Omega}^2$, $\forall \mathcal{V} \in \mathcal{K}$. Hence the coercivity of the function \mathcal{L} on \mathcal{K} is obvious:

$$\mathcal{L}(\mathcal{V}) = \frac{1}{2} \mathcal{B}(\mathcal{V}, \mathcal{V}) - L(\mathcal{V}) \ge \frac{c_0}{2} |\mathcal{V}|^2 - L(\mathcal{V}) \ge c_1 ||\mathcal{V}||_{1,\Omega}^2 - ||L|| ||\mathcal{V}||_{1,\Omega}, \quad \forall \, \mathcal{V} \in \mathcal{K}.$$

Therefore Problem 1 has a variational solution.

Let now $\overset{1}{\mathcal{U}}$ and $\overset{2}{\mathcal{U}}$ be solutions of the problem. Then $\mathcal{Z} = \overset{1}{\mathcal{U}} - \overset{2}{\mathcal{U}} \in \mathcal{R}_V$ and $\mathcal{L}(\overset{1}{\mathcal{U}}) = \mathcal{L}(\overset{2}{\mathcal{U}}) \Longrightarrow L(\overset{2}{\mathcal{U}}) \Longrightarrow L(\mathcal{Z}) = 0$. By virtue of (20) we conclude that $\mathcal{Z} = 0$.

Finally, if (21) is fulfilled, then the existence of a variational solution of Problem 1 is guaranteed by Theorem 1 (in our case $\mathcal{R}^* = \{0\}$). The uniqueness is proved similarly to the previous case. \square

Remark 1. If $V \cap \mathcal{R} = \{0\}$, then an equality of the Korn type $|\mathcal{V}| \geq c ||\mathcal{V}||_{1,\Omega}$, $\forall \mathcal{V} \in V$, is valid and therefore \mathcal{L} is coercive on the space V, which fact in its turn enables one to assert the existence and uniqueness of a variational solution of Problem 1.

II. PROBLEMS WITH AN EXPANDING CONTACT ZONE

We have considered the contact problem in which during deformation the contact zone does not extend beyond the boundary of some domain. However in some cases the contact zone may expand. Such a situation occurs when the domains Ω_1 and Ω_2 possess smooth boundaries in some neighborhood of the intersection $\partial \Omega_1 \cap \partial \Omega_2$.

Let $Q \in \partial \Omega_1 \cap \partial \Omega_2$ be an arbitrary point in the contact zone in the undeformed state. We introduce the local Cartesian system (ξ, η) so that the ξ -axis be directed along $n^{(1)}$, and the η -axis along the tangent to the point Q. Let, furthermore, the parts of the boundary $\partial \Omega_1$ and $\partial \Omega_2$ which might come into contact during deformation be described in terms of local coordinates as $\Gamma_c^{(q)} = \{(\xi, \eta) | \xi = f^{(q)}(\eta), \quad a \leq \eta \leq b\}, \quad q = 1, 2$, where $f^{(q)}$ are the continuous functions on [a, b] (this segment is chosen so that it includes the projection of a possible contact zone onto the η -axis).

To avoid repetition, we do not formulate completely the contact problem which we are going to consider below (referred to as Problem 2) because it is formulated exactly like Problem 1 with the only difference that conditions $(7)_1$, $(7)_2$ and $(7)_3$ are replaced (see [6]) by the conditions

$$u_{\xi}^{(2)} - u_{\xi}^{(1)} \leq \varepsilon(\eta), \quad -\binom{(1)}{\sigma} \mathcal{U}^{(1)} \rangle_{\xi} (\cos \alpha^{(1)})^{-1} = \binom{(2)}{\sigma} \mathcal{U}^{(2)} \rangle_{\xi} (\cos \alpha^{(2)})^{-1} \leq 0; \quad (7)_{1}'$$

$$\left\langle {\binom{2}{\sigma} \mathcal{U}^{(2)}}_{\xi}, \ u_{\xi}^{(2)} - u_{\xi}^{(1)} - \varepsilon(\eta) \right\rangle = 0;$$
 (7)₂

$$(\overset{(1)}{\sigma}\mathcal{U}^{(1)})_{\eta} = (\overset{(2)}{\sigma}\mathcal{U}^{(2)})_{\eta} = 0,$$
 (7)'₃

where $\varepsilon(\eta) = f^{(1)}(\eta) - f^{(2)}(\eta)$, $\eta \in [a,b]$, is a distance between the boundaries of the elastic bodies prior to deformations, $u_{\xi}^{(q)}$ are components of the dispacement vectors along the ξ -axis, $\alpha^{(q)}$ is the angle formed by the η -axis and the tangent to $\Gamma_c^{(q)}$, and $\cos \alpha^{(q)} = [1 + (df^{(q)}/d\eta)^2]^{-1/2}$.

Let us again introduce the space V and the convex closed set $\mathcal{K}_{\varepsilon}$ as follows:

$$\begin{split} V &= \Big\{ \mathcal{V} \in \mathcal{H}^{1}(\Omega); \mathcal{V}^{(1)} \Big|_{\Gamma_{u}} = 0, \ v^{(2)} \cdot n^{(2)} \Big|_{\Gamma_{0}} = w^{(2)} \cdot n^{(2)} \Big|_{\Gamma_{0}} = 0, \\ w^{(1)} \Big|_{\Gamma_{c}^{(1)}} &= w^{(2)} \Big|_{\Gamma_{c}^{(2)}} \ \text{with the same coordinate} \ \eta \in [a, b] \Big\}, \\ \mathcal{K}_{\varepsilon} &= \Big\{ \mathcal{V} \in V; \ v_{\xi}^{(2)} - v_{\xi}^{(1)} \leq \varepsilon(\eta), \ \eta \in [a, b] \Big\}. \end{split}$$

The functionals L and \mathcal{L} are the same as before.

Definition 3. A function $\mathcal{U} \in \mathcal{K}_{\varepsilon}$ is called a variational solution of Problem 2 if $\mathcal{L}(\mathcal{U}) \leq \mathcal{L}(\mathcal{V})$, $\forall \mathcal{V} \in \mathcal{K}_{\varepsilon}$.

Our next proposition below is proved quite similarly to Proposition 1.

Proposition 2. Each solution of Problem 2 is a variational solution of this problem and vice versa.

Let formulate without proving a result similar to Theorem 2.

Theorem 4. Let

$$\mathcal{K}_0 = \left\{ \mathcal{V} \in V; \, v_{\xi}^{(2)} - v_{\xi}^{(1)} \le 0, \, \forall \, \eta \in [a; b] \right\}$$
$$L(Y) = 0, \quad \forall \, Y \in \mathcal{R}_V \equiv \mathcal{K}_0 \cap \mathcal{R}.$$

and $V = H \oplus \mathcal{R}_V$ be the orthogonal decomposition of the space V.

Then \mathcal{L} is coercive on H and there exists a unique solution $\widehat{\mathcal{U}} \in \widehat{\mathcal{K}}_{\varepsilon} = \mathcal{K}_{\varepsilon} \cap H$ of the problem

$$\mathcal{L}(\widehat{\mathcal{U}}) \le \mathcal{L}(\mathcal{Z}), \quad \forall \, \mathcal{Z} \in \widehat{\mathcal{K}}_{\varepsilon}.$$
 (25)

Moreover, each variational solution of Problem 2 can be written in the form $\mathcal{U} = \hat{\mathcal{U}} + Y$, where $\hat{\mathcal{U}}$ is a solution of (25) and $Y \in \mathcal{R}_V$. If $\hat{\mathcal{U}} \in \mathcal{R}_V$ is a solution of (25), then $\hat{\mathcal{U}} + Y$ is a variational solution of Problem 2 for any $Y \in \mathcal{R}_V$.

The proof of this theorem repeats that of Theorem 2. Finally, the following theorem is valid.

Theorem 5. Let Γ_0 consist of segments parallel to the x_1 -axis, $\cos(\xi, x_1) > 0$ and

$$U_1^{(2)} = \int_{\Omega_2} F_1^{(2)} dx + \left\langle \mathcal{P}_1^{(2)}, 1 \right\rangle > 0.$$
 (26)

Then \mathcal{L} is coercive on $\mathcal{K}_{\varepsilon}$ and there exists a unique solution of Problem 2.

Proof. Let

$$Q(\mathcal{V}) = \int_{a}^{b} (v_{\xi}^{(2)} - v_{\xi}^{(1)}) d\eta \text{ and } V_{Q} = \{ \mathcal{V} \in V; Q(\mathcal{V}) = 0 \}.$$

Then

$$\mathcal{R} \cap V_Q = \{0\}. \tag{27}$$

Indeed,

$$\mathcal{R} \cap V_Q \subset \mathcal{R}_V = \{ Y = (Y^{(1)}, Y^{(2)}); Y^{(2)} = ((0, 0); 0), Y^{(2)} = ((b_1, 0); 0), b_1 \in \mathcal{R}^1 \}.$$

Since Q(Y) = 0, we have

$$0 = b_1 \int_a^b \cos(\xi, x_1) d\eta \Longrightarrow b_1 = 0.$$

Using (27) and the second Korn inequality, one can prove that

$$|\mathcal{V}| \ge c \|\mathcal{V}\|_{1,\Omega}, \quad \forall \, \mathcal{V} \in V_Q. \tag{28}$$

Let $\mathcal{V} \in V$. Choosing $Y \in \mathcal{R}_V$ such that $Y^{(1)} = ((0,0);0), \quad Y^{(2)} = ((Q(\mathcal{V})d^{-1},0);0)$, where

$$d = \int_{a}^{b} \cos(\xi, x_1) d\eta,$$

observing that the equality

$$Q(P\mathcal{V}) = Q(\mathcal{V}) - Q(Y) = Q(\mathcal{V}) - \int_{a}^{b} Q(\mathcal{V})d^{-1}\cos(\xi, x_1)d\eta = 0$$

holds for the difference PV = V - Y, we find that $PV \in V_Q$. By (28) we have

$$\mathcal{L}(\mathcal{V}) = \frac{1}{2}\mathcal{B}(P\mathcal{V}, P\mathcal{V}) - L(P\mathcal{V}) - L(Y)$$

$$\geq c_1 \|P\mathcal{V}\|_{1,\Omega}^2 - c_2 \|P\mathcal{V}\|_{1,\Omega} - Q(\mathcal{V})d^{-1}U_1^{(2)}.$$
(29)

Clearly, if $\|\mathcal{V}\|_{1,\Omega} \longrightarrow \infty$, then at least one of the norms $\|P\mathcal{V}\|_{1,\Omega}$ or $\|Y\|_{1,\Omega}$ tends to infinity. Moreover,

$$\mathcal{V} \in \mathcal{K}_{\varepsilon} \Longrightarrow Q(\mathcal{V}) \le \int_{a}^{b} \varepsilon(\eta) d\eta < +\infty,$$
 (30)

$$||Y||_{1,\Omega} = |Q(\mathcal{V})|d^{-1}\left(\int_{\Omega_2} dx\right)^{1/2} = |Q(\mathcal{V})|d^{-1}(\text{mes }\Omega_2)^{1/2}.$$
 (31)

- 1. Let $||Y||_{1,\Omega} \longrightarrow \infty$. From (30) and (31) it follows that $-Q(\mathcal{V}) \longrightarrow +\infty$. Since $c_1 ||P\mathcal{V}||_{1,\Omega}^2 c_2 ||P\mathcal{V}||_{1,\Omega} \ge c_3 > -\infty$, (29) and (26) imply that $\mathcal{L}(\mathcal{V}) \longrightarrow +\infty$.
 - 2. Let now $\|P\mathcal{V}\|_{1,\Omega} \longrightarrow \infty$. Then (30) yields

$$c_1 \|PV\|_{1,\Omega}^2 - c_2 \|PV\|_{1,\Omega} \longrightarrow +\infty, \quad -Q(V)d^{-1}U_1^{(2)} \ge -d^{-1}U_1^{(2)} \int_a^b \varepsilon d\eta > -\infty.$$

Hence, by (29), we obtain $\mathcal{L}(\mathcal{V}) \longrightarrow +\infty$. Thus we have proved the coercivity of the functional \mathcal{L} on $\mathcal{K}_{\varepsilon}$, which in its turn guarantees the existence of a solution of Problem 2. Let \mathcal{U} and \mathcal{U} be any two solutions. Then $\mathcal{Z} = \mathcal{U} - \mathcal{U} \in \mathcal{R}_V$ and $L(\mathcal{Z}) = 0$. On the other hand, $L(\mathcal{Z}) = bU_1^{(2)}$, $b \in \mathcal{R}^1$, and (26) implies that b = 0, i. e., $\mathcal{Z} = 0$. The uniqueness and, accordingly, Theorem 5 is proved. \square
