On the Multispecies Delayed Gurtin-MacCamy Model

The paper deals with the description of multispecies model with delayed dependence on the size of population. It is based on the Gurtin and MacCamy model. The existence and uniqueness of the solution for the new problem of *n* populations dynamics are proved, as well as the asymptotical stability of the equilibrium age distribution.

1. Introduction

In this paper we consider mutual influence of n populations. We assume that each population develops differently, affecting each other. Populations do not destroy each other. However, they share the same natural resources and the space. In our model u denotes the density of the ecosystem consisting of n different populations. Therefore $u = (u^1, \ldots, u^n)$ is the vector function. Each component u^i for $i = 1, \ldots, n$ denotes the ith population density. The development of ith population can be expressed by the following system of the equations:

The rate

denotes the intensity of changing of the ith population in time. In particular, if u^i is differentiable then $Du^i = \partial u^i/\partial a + \partial u^i/\partial t$. The quantity $z^i(t)$ is the total ith population at time t. We can express total population of the whole ecosystem at time t by

We assume that

The birth and death processes of the ith population are described by coefficients λ^i and β^i . We assume that both processes depend on the population size not only at the moment t, but also at any preceding period of time (so-called history segment). Introducing the delay parameter to the model has deep biological approach (see, for instance, [1]). All natural processes occur with some delay with respect to the moment of their initiation. We can take into consideration, for example, the period of pregnancy (constant delay) or morbidity (variable delay). In our model, considered processes occur with n various delays, typical for n populations. It is a novel approach to the population dynamics research. Moreover the system (1)–(4) consists of the general description of npopulations dynamics. If populations develop independently, then the functions λ^i and β^i depend on ith coordinate of the function z_t only and the system consists of n independent von Foerster equations. However, if there are populations relationships, we can consider three cases.

- (1) Competition for food: in this case β^i is decreasing function of variables describing the numbers of species competing for food with the ith one. For example, $\beta^i(a, z) = \max\{a(F \sum_{j \in I} k_j z_j), 0\}$, where F denotes total amount of food and I is the set of species competing with the ith one.
- (2) Schema predator prey: if *i*th species feeds on *j*th species individuals, then λ^j and β^i are increasing functions of variables z^j and z^i , respectively. The classical models show that balance state between two species competing for food is not possible. In this case the model does not have nonzero equilibrium age distribution. However, if we additionally consider predator feeding on one competing species, then we get balance between three considered species (see, for instance, [2–5]).
- (3) Symbiosis: if *i*th and *j*th species live in symbiosis with each other, then β^i can be an increasing function of z^j (when the presence of *j*th species individuals is the reproduction of *i*th species favour) or λ^j is a decreasing function of z^i (when the presence of *i*th species protects *j*th species individuals from death).

In this paper we develop the idea of Gurtin and MacCamy model [6] for one age-dependent population

This classical model has many generalizations [7–16]. Considerations of the dynamics of age-structured populations

have received substantial treatment on various fields [17–22]. In particular our latest extension of this theme was presented in the article [10], where we considered an age-dependent population dynamics with a delayed dependence on the structure. The right-hand side of the equation in our model is not in the form λu but Δu . Here Δu is an operator that does not apply to the value of the function u, as in the classical model, but to its restriction to some particular space:

In our paper [10] we present the proof of the existence and uniqueness of the new problem solution. Conditions of the exponential asymptotical stability for this model still remain to be formulated. On account of the significant difficulties with formulating conditions of the stability we consider slightly simpler version of the model than the one described in [10]. We resign from the delay in the structure during a deliberation on mortality. However, the delayed dependence of the structure still remains the element of the birth process description. In this paper we aim to state stability conditions for the ecosystem of n populations. The plan of the paper is as follows. In Section 2 we formulate the problem in the terms of operator equations. Section 3 contains the proof of the existence and uniqueness of the solution. We also study equilibrium age distributions, that is, solutions to the problem which are independent of time. In Section 4 exponential asymptotic stability of the equilibrium age distributions is analyzed. We use generalized Laplace transform to study the stability.

We consider our model (1)–(4) under the following assumptions.

- (H_5) The components of the function $\lambda(\cdot, \psi) = (\lambda^1(\cdot, \psi), \ldots, \lambda^n(\cdot, \psi))$ belong to $C(C([-r^i, 0]); L^{\infty}(\mathbb{R}_+))$, respectively, for $i = 1, \ldots, n$.
- (H_6) The components of Fréchet derivative $D_{\psi_0}\lambda = (D_{\psi_0}\lambda^1, \ldots, D_{\psi_0}\lambda^n)$ in the point ψ_0 as functions of ψ_0 belong to $C(C([-r^i, 0]); \mathcal{L}(C([-r^i, 0]), L^{\infty}(\mathbb{R}_+)))$, $i = 1, \ldots, n$. Here $\mathcal{L}(X, Y)$ denotes the Banach space of all bounded linear operators from X to Y.

- $(H_7) \varphi^i \geqslant 0, \ \lambda^i \geqslant 0, \ \beta^i \geqslant 0 \text{ for } i = 1, \dots, n.$
- (H_8) The functions λ and β are bounded; that is, $\|\lambda(a,\psi)\| \leq \lambda_0$ and $\|\beta(a,z)\| \leq \beta_0$ where λ_0 and β_0 are finite quantities.

2. Equivalent Formulation of the Problem

In this section we will formulate problem (1)–(4) in terms of operator equations. Thanks to this we will prove local and global existences of the presented problem solution. The next theorem is analogous to these well-known results, for example, von Foerster [23] or Gurtin and MacCamy models.

Theorem 1. Nonnegative continuous functions $z_t = (z_t^1, ..., z_t^n)$ and $B = (B^1, ..., B^n)$, where

for i = 1, ..., n, are the solutions of the problems (2) and (3) up to time T > 0 if and only if the function $u = (u^1, ..., u^n)$ is the solution of the age-dependent n populations problem (1)–(4) on [0, T] and u is defined by the formula

Proof. The idea of the proof is analogous to the result included in the paper [9], treating the theme of the age-dependent

population problem for one species. Let $u=(u^1,\ldots,u^n)$ be a solution of the problem up to time T. Let $\overline{u}^i(h)=u^i(a_0+h,t_0+h), \overline{\lambda}^i(h)=\lambda^i(a_0+h,z_{t_0+h})$ then we can rewrite (1) as the equation $d\overline{u}^i/dh+\overline{\lambda}^i(h)\overline{u}^i=0$ with the unique solution

Substituting $(a_0, t_0) = (a - t, 0)$, h = t and $(a_0, t_0) = (0, t - a)$, h = a into (17) yields the formula (16). Applying (16) to (2) and (3) we obtain the operator equations (14) and (15).

To prove the second part of the theorem we should assume that $z_t^i \ge 0$ and $B^i \ge 0$ for i = 1, ..., n are continuous functions on the interval [0,T] fulfilling conditions (14) and (15). Let u for each component u^i be defined on $\mathbb{R}_+ \times [0,T]$ by the formula (16). The function u is nonnegative because of (H_7) . An easy computation shows that (4) holds, and u(0,t) = B(t) for t > 0. $u \in L^1(\mathbb{R}_+)$ because λ , β , and z_t are continuous and $\varphi \in L^1(\mathbb{R})$. It follows from (14)–(16) that (2) and (3) are satisfied. To complete the proof, let us notice that (6) and (16) imply existing Du on $\mathbb{R}_+ \times [0,T]$ and the equality (1) holds.

Let us make some estimation for the necessity of the next section. We turn back to the operator equation (14). By the assumptions (H_2) and (H_8) we get

3. Existence and Uniqueness

According to the theorem in Section 2 to solve the population problem up to time T it is sufficient to find functions $z=(z^1,\ldots,z^n)\in \bigvee_{i=1}^n C^+([-r^i,T])$ and $B=(B^1,\ldots,B^n)\in \bigvee_{i=1}^n C^+([-r^i,T])$ satisfying the system of operator equations (14) and (15). We can notice that (14) is a Volterra equation of B^i with a unique solution $\mathcal{B}^i_T(z)$. Let us define on $\bigvee_{i=1}^n C^+([-r^i,T])$ the new operator $\mathcal{Z}_T=(\mathcal{Z}_T^1,\ldots,\mathcal{Z}_T^n)$ where

Theorem 2. The operator \mathcal{Z}_T : $\times_{i=1}^n C^+[-r^i, T] \to \times_{i=1}^n C^+[-r^i, T]$ defined by (22) has a unique fixed point for any T > 0.

Proof. We prove that the operator \mathcal{Z}_T is contracting, and then the assertion will be a consequence of the Banach fixed point theorem. Let us consider the Banach space $C[-r^i,T]$ with the Bielecki norm $\|f^i\|_T = \sup_{t \in [-r^i,T]} e^{-Kt} |f^i(t)|$ for any K > 0. Such norm is equivalent to classical supremum norm $\|\cdot\|$ in $C[-r^i,T]$. Choose z, $\widehat{z} \in X_{i=1}^n C[-r^i,T]$. Applying the definition (22) we obtain

Estimating the quantities I_1 , I_2 , and I_3 we use the assumptions (H_2) , (H_7) , and (H_8) , inequalities (21) and $|e^k-1| \le |k|e^{|k|}$. Thus

According to the previous mentioned there exists the exact one solution for any interval [0,T] so the solutions defined on two different intervals coincide on their intersection. By the extension property we have the existence and uniqueness of the n populations problem solution for all times.

4. Stability of Equilibrium Age Distribution

A stationary solution $u(a) = (u^1(a), ..., u^n(a))$ of the model (1)–(4) satisfies the following system of the equations:

We can notice that the last two elements of the expression defining $\mathbf{f}^{i}(t)$ equal zero for t > r.

We return to the previous deliberation in the next theorem. We take some additional assumptions.

- (H_{10}) The Fréchet derivatives $D_{z^i}\lambda^i(a,z_0)$ and the derivation $D_{z^i}\beta^i(a,z_0)$ for $i=1,2\ldots,n$ as functions of the variable a belong to $L^{\infty}(\mathbb{R}_+)$.
- (H_{11}) $(\Lambda^i(a,\rho)/\|\rho\|_0)$ and $(\Omega^i(a,\rho)/\|\rho\|_0)$ tend to zero as $\|\rho\|_0 \to 0$ uniformly for $a \to 0$; here $\|\cdot\|_0$ denotes the supremum norm in the Banach space $C([-r^i,0])$.

$$(H_{12}) \lambda_* = \inf_{\substack{a>0\\a>0}} \{\lambda^i(a, z_0), i = 1, 2, \dots, n\} > 0.$$

Denote $e_{\theta}: (-\infty, 0] \to \mathbb{R}$ by the formula $e_{\theta}(s) = e^{\theta s}$. The exponential asymptotical stability of the model is established by the following theorem.

Theorem 4. Let $\widetilde{\pi}_1^i(a,a+t) = \int_{[-r,0]} \beta_0^i(a+t+s^i)\widetilde{\pi}_0^i(a,a+t+s^i)ds$, and let $\pi_1^i(t) = \int_{[-r,0]} \beta_0^i(t+s^i)\pi_0^i(t+s^i)ds$. Let us assume that there exists some $\overline{\mu} > 0$ that the equation

$$1 = \int_{0}^{\infty} e^{-t\gamma} \pi_{1}^{i}(t) dt$$

$$- \int_{0}^{\infty} e^{-t\gamma} \int_{0}^{\infty} \widetilde{\pi}_{0}^{i}(a, a+t) \omega^{i}(a) \left(e_{\gamma}\right) da dt$$

$$\cdot \left(1 - \int_{0}^{\infty} e^{-t\gamma} \pi_{1}^{i}(t) dt\right)$$

$$- \int_{0}^{\infty} e^{-t\gamma} \pi_{0}^{i}(t) dt$$

$$\cdot \left(\int_{0}^{\infty} e^{-t\gamma} \int_{0}^{\infty} \widetilde{\pi}_{1}^{i}(a, a+t) \omega^{i}(a) \left(e_{\gamma}\right) da dt - \kappa^{i}\left(e_{\gamma}\right)\right)$$
(68)

has no solution γ with $\text{Re}(\gamma) \geqslant -\overline{\mu}$. Then there exist real numbers $\delta > 0$ and $\mu > 0$ such that for any initial data φ with $\|\varphi - u_0\|_{L^1} < \delta$, the corresponding solution of the population problem (1)–(4), if it exists for t > 0, satisfies

$$||z_t - z_0|| = O\left(e^{-\mu t}\right),\tag{69}$$

$$\|u(a,t) - u_0(a)\| = O(e^{-\mu t})$$
 for each a
as $t \longrightarrow \infty$. (70)

Proof. Let u be the solution of the population problem (1)–(4) for t > 0. In the proof we will use the properties of the generalized Laplace transform. Let $\varrho : [0, \infty) \to C([-r^i, 0])^*$ be the function with measure value. Define

$$\widehat{\varrho}(\theta) = \int_{0}^{\infty} \varrho(t) \left(e_{\theta}\right) e^{-\theta t} dt. \tag{71}$$

If we define the convolution by the formula

$$\left(\varrho * \nu_{\tau}\right)(t) = \int_{0}^{t} \varrho(t - \tau) \nu(\tau + \cdot) d\tau, \tag{72}$$

where v(t) = 0 for t < 0, then we have the equality analogous to the property of classical Laplace transform, that is,

$$\widehat{\varrho * \nu_{\tau}}(\theta) = \widehat{\varrho}(\theta)\,\widehat{\nu}(\theta). \tag{73}$$

Using generalized Laplace transform to (63) we get

$$\widehat{\mathbf{A}}(\theta)\widehat{\mathbf{y}}(\theta) + \widehat{\mathbf{K}}(\theta)\widehat{\mathbf{y}}(\theta) = \widehat{\mathbf{f}}(\theta), \tag{74}$$

where

$$\widehat{\mathbf{A}}(\theta) = \begin{bmatrix} \widehat{\mathbf{A}}^{1}(\theta) & \mathbf{O} & \cdots & \mathbf{O} \\ \mathbf{O} & \widehat{\mathbf{A}}^{2}(\theta) & \cdots & \mathbf{O} \\ \vdots & \vdots & \ddots & \vdots \\ \mathbf{O} & \mathbf{O} & \cdots & \widehat{\mathbf{A}}^{n}(\theta) \end{bmatrix},$$

$$\widehat{\mathbf{A}}^{i}(\theta) = \begin{bmatrix} 1 & 0 \\ -\kappa^{i}(e_{\theta}) & 1 \end{bmatrix},$$

$$\widehat{\mathbf{K}}^{1}(\theta) & \mathbf{O} & \cdots & \mathbf{O} \end{bmatrix}$$

$$\widehat{\mathbf{K}}\left(\boldsymbol{\theta}\right) = \begin{bmatrix} \widehat{\mathbf{K}}^{1}\left(\boldsymbol{\theta}\right) & \mathbf{O} & \cdots & \mathbf{O} \\ \mathbf{O} & \widehat{\mathbf{K}}^{2}\left(\boldsymbol{\theta}\right) & \cdots & \mathbf{O} \\ \vdots & \vdots & \ddots & \vdots \\ \mathbf{O} & \mathbf{O} & \cdots & \widehat{\mathbf{K}}^{n}\left(\boldsymbol{\theta}\right) \end{bmatrix},$$

 $\widehat{\mathbf{K}}^{i}(\theta)$

$$= \left[\int_{0}^{\infty} e^{-t\theta} \int_{0}^{\infty} \widetilde{\pi}_{0}^{i} (a, a+t) \omega^{i} (a) (e_{\theta}) da dt - \widehat{\pi}_{0}^{i} (\theta) \right]$$

$$= \left[\int_{0}^{\infty} e^{-t\theta} \int_{0}^{\infty} \widetilde{\pi}_{1}^{i} (a, a+t) \omega^{i} (a) (e_{\theta}) da dt - \widehat{\pi}_{1}^{i} (\theta) \right]$$
(75)

for $\widetilde{\pi}_1^i(a,a+t)=\int_{[-r,0]}\beta_0^i(a+t+s^i)\widetilde{\pi}_0^i(a,a+t+s^i)ds$ and $\pi_1^i(t)=\int_{[-r,0]}\beta_0^i(t+s^i)\pi_0^i(t+s^i)ds$. From the equality (68) we conclude that the matrix $\widehat{\bf A}+\widehat{\bf K}$ has an analytic inverse for ${\rm Re}(\theta)\geqslant -\overline{\mu}$. Moreover, we have

$$\widehat{\mathbf{A}}^{-1}(\theta) = \begin{bmatrix} \left(\widehat{\mathbf{A}}^{1}\right)^{-1}(\theta) & \mathbf{O} & \cdots & \mathbf{O} \\ \mathbf{O} & \left(\widehat{\mathbf{A}}^{2}\right)^{-1}(\theta) & \cdots & \mathbf{O} \\ \vdots & \vdots & \ddots & \vdots \\ \mathbf{O} & \mathbf{O} & \cdots & \left(\widehat{\mathbf{A}}^{n}\right)^{-1}(\theta) \end{bmatrix}, (76)$$
$$\left(\widehat{\mathbf{A}}^{i}\right)^{-1}(\theta) = \begin{bmatrix} 1 & 0 \\ \kappa^{i}\left(e_{\theta}\right) & 1 \end{bmatrix},$$

so $\widehat{\mathbf{A}}$ is analytic for $\theta \in \mathbb{C}$.

The solution of the matrix equation (63) exists and is given by

$$\mathbf{y}(t) = \mathbf{A}^{-1}\mathbf{f}_t + \int_0^t \mathbf{J}(t - \tau) \,\mathbf{f}_\tau d\tau, \tag{77}$$

where
$$\mathbf{f}_{\tau}(s) = \begin{bmatrix} \mathbf{f}^{1}(\tau+s) \\ \vdots \\ \mathbf{f}^{n}(\tau+s) \end{bmatrix}$$
, $\mathbf{f}_{\tau}^{i}(s) = \mathbf{f}^{i}(\tau+s)$ for $s \in [-r^{i}, 0]$ and

$$J(t) = \frac{1}{2\pi} e^{-\overline{\mu}t} \int_{-\infty}^{\infty} e^{i\zeta t} \widehat{J}(-\overline{\mu} + i\zeta) d\zeta.$$
 (78)

 $\widehat{J} = (\widehat{A}(\theta) + \widehat{K}(\theta))^{-1} - \widehat{A}^{-1}(\theta)$ is the Laplace transform of the function J and

$$|\mathbf{J}(t)| \leqslant C_1 e^{-\overline{\mu}t},\tag{79}$$

where $|\mathbf{J}|$ denotes the sum of moduli of the elements of the matrix **J**. Here and in the whole proof C_1, C_2, C_3, \ldots denote positive constants.

By (H_{12}) , (32), and (54)

$$\pi_0^i(a) \leqslant e^{-\lambda_* a}, \quad \widetilde{\pi}_0^i(a', a) \leqslant e^{-\lambda_* (a - a')} \quad (a' \leqslant a).$$
(80)

For $\lambda_* > \overline{\mu}$ and $\|\beta_0\|_{L^{\infty}} < \infty$ we can estimate that

$$\|\mathbf{f}(t)\| \leq C_2 \left\{ \int_0^t e^{-\lambda_*(t-\tau)} \|x(\cdot,\tau)\|_{L^1} d\tau + \|\eta\|_{L^1} e^{-\lambda_* t} + \|\psi(t)\|_{L^1} \right\},$$
(81)

$$\|\mathbf{y}(t)\| \leq C_{3} \left\{ \|\eta\|_{L^{1}} e^{-\overline{\mu}t} + \|\psi(t)\|_{L^{1}} + \int_{0}^{t} e^{-\overline{\mu}(t-\tau)} \left[\|\psi(\tau)\|_{L^{1}} + \|x(\cdot,\tau)\|_{L^{1}} \right] d\tau \right\},$$
(82)

where $\|\mathbf{y}(t)\| = \left(\sum_{i=1}^{n} (p^{i})^{2} + (b^{i})^{2}\right)^{1/2}$

$$\begin{split} \left\| \xi \left(\cdot, t \right) \right\|_{L^{1}} & \leq \int_{0}^{t} e^{-\lambda_{*}\tau} \left\| b \left(t - \tau \right) \right\| d\tau + \left\| \eta \right\|_{L^{1}} e^{-\lambda_{*}t} \\ & + \int_{0}^{t} e^{-\lambda_{*}(t-\tau)} \left(\left\| x \left(\cdot, \tau \right) \right\|_{L^{1}} + \left\| \omega \right\|_{L^{1}} \left\| p_{\tau} \right\|_{0} \right) d\tau \\ & \leq C_{4} \left\{ \left\| \eta \right\|_{L^{1}} e^{-\overline{\mu}t} \right. \\ & \left. + \int_{0}^{t} e^{-\overline{\mu}(t-\tau)} \right. \\ & \times \left[\left\| \psi \left(\tau \right) \right\|_{L^{1}} + \left\| x \left(\cdot, \tau \right) \right\|_{L^{1}} \right] d\tau \right\}. \end{split}$$

Let $\varepsilon > 0$. By (H_{11}) there exists $\tilde{\delta} = \tilde{\delta}(\varepsilon)$ such that

$$\|\Lambda(a, p_t)\| \le \varepsilon \|p_t\|_0, \qquad \|\Omega(a, p_t)\| \le \varepsilon \|p_t\|_0$$
 (84)

for $\|p_t\|_0 < \tilde{\delta}$. By the previous inequalities and the fact that $\|D_z\lambda(a,z_0)\|_{L^\infty}$, $\|D_z\beta(a,z_0)\|_{L^\infty}$, and $\|u_0\|_{L^1}$ are finite, we can estimate that

$$\|x(\cdot,t)\|_{L^{1}}, \|\psi(t)\|_{L^{1}} \leq C_{5} \{\|p_{t}\|_{0} \cdot \|\xi(\cdot,t)\|_{L^{1}} + \varepsilon \|p_{t}\|_{0} \}.$$
(85)

We require that $\varepsilon < 1$ and $\widetilde{\delta} < \varepsilon$. Hence $\| p_t \|_0 < \varepsilon$. According to the previous remarks, we have

$$\|x(\cdot,t)\|_{L^{1}}, \|\psi(t)\|_{L^{1}} \leq C_{5}\varepsilon\sigma(t),$$

$$\sigma(t) = \|\xi(\cdot,t)\|_{L^{1}} + \|p_{t}\|_{0}.$$
(86)

Thus (82)–(86) imply that

$$\sigma(t) \leq M \left\{ \|\eta\|_{L^1} e^{-\overline{\mu}t} + 2\varepsilon \int_0^t e^{-\overline{\mu}(t-\tau)} \sigma(\tau) d\tau \right\}, \qquad (87)$$

where M > 0. Gronwall's inequality yields

$$\sigma(t) \leqslant M \|\eta\|_{I^1} e^{(-\overline{\mu} + 2M\varepsilon)t}. \tag{88}$$

Let us choose δ and $\varepsilon > 0$ such that $\mu = \overline{\mu} - 2M\varepsilon > 0$ and $\delta < \min (\widetilde{\delta}(\varepsilon), \widetilde{\delta}(\varepsilon)/M)$. Assume that $\| \varphi - u_0 \|_{L^1} = \| \eta \|_{L^1} < \delta$. In that case, from what has already been proved, it follows that $\| x(\cdot,t)\|_{L^1}, \| \psi(t)\|_{L^1}, \sigma(t)$ and $\|b(t)\|$ are $O(e^{-\mu t})$. Therefore (41), (86)₂ imply (69) and (53)₂, (80), and (39) imply (70). \square

Example 5. Let n = 2. Let us consider

$$\lambda^{i}(a,z) = \lambda^{i}(a,z_{1}^{1},z_{2}^{1},z_{1}^{2},z_{2}^{2}),$$

$$\beta^{i}(a,z) = \beta^{i}(a,z^{1},z^{2}),$$
(89)

where

$$\lambda^{i}(a,z) = \lambda^{i}(z^{1}(0), z^{1}(-r^{1}), z^{2}(0), z^{2}(-r^{2})),$$

$$\beta^{i}(a,z) = \beta^{i}(z^{1}, z^{2})e^{-\alpha^{i}a}$$
(90)

with $\lambda^i > 0$, $\beta^i > 0$, $r^i > 0$, $\alpha^i > 0$ for i = 1, 2. Let us define

$$\lambda_0^i = \lambda^i \left(z_0^1, z_0^1, z_0^2, z_0^2 \right),$$

$$\beta_0^i = \beta^i \left(z_0^1, z_0^2 \right) e^{-\alpha^i a}$$
(91)

for an arbitrary $z_0=(z_0^1,z_0^2)\in\mathbb{R}^2$. From (32) and (33) we conclude that

$$\pi_0^i(a) = e^{-a\lambda_0^i},$$

$$R^i(z_0) = \frac{r^1 r^2 \beta_0^i}{\alpha^i + \lambda_0^i}.$$
(92)

By Theorem 3 there exists an equilibrium age distribution $u_0^i(a)=z_0^i\lambda_0^ie^{-\lambda_0^ia}$ where $B_0=z_0^i\lambda_0^i$ if and only if $r^1r^2\beta_0^i/(\alpha^i+\lambda_0^i)=1$. To investigate the stability of the equilibrium age

distribution we consider (68). Let $z_0 = (z_0^1, z_0^2)$ be the solution of the system of the equations

$$R^{i}(z_{0}) = 1, \quad i = 1, 2.$$
 (93)

First, let us notice that

$$\omega^{i}\left(e_{\gamma}\right) = \left(\frac{\partial\lambda^{i}}{\partial z_{1}^{i}} + \frac{\partial\lambda^{i}}{\partial z_{2}^{i}}e^{-\gamma r^{i}}\right)\lambda_{0}^{i}z_{0}^{i} e^{-a\lambda_{0}^{i}} \tag{94}$$

with the derivatives in the point z_0 . It is easy to notice that $|\partial \lambda^i/\partial z_1^i + (\partial \lambda^i/\partial z_2^i)e^{-\gamma r^i}|$ is bounded on half-plane $\text{Re}(\gamma) > \mu$ for every real μ (also negative). Analogously

$$\kappa^{i}\left(e_{\gamma}\right) = \frac{\lambda_{0}^{i}}{\beta_{0}^{i}} \cdot \frac{z_{0}^{i}}{r^{i}} \cdot \frac{\partial \beta^{i}}{\partial z^{i}} \left(z_{0}\right) \int_{-r^{i}}^{0} e^{\gamma s} ds. \tag{95}$$

It is also possible to prove that for every real μ the function $|\kappa^i(e_\gamma)|$ is bounded on half-plane $\mathrm{Re}(\gamma) > \mu$. Consider the right-hand side of (68). All components can be presented in the form

$$\frac{A}{B+\nu},\tag{96}$$

where *A* is bounded and $B \ge \max\{\alpha^i, \lambda_0^i\}$. Let $\mu < B$, and let $\text{Re}(\gamma) > -\mu$:

$$\left| \frac{A}{B+\gamma} \right| = \left| \frac{A}{B-\mu+\mu+\gamma} \right| \le \left| \frac{A}{B-\mu+\mu+\operatorname{Re}(\gamma)} \right|$$

$$\le \left| \frac{A}{2\sqrt{B-\mu}\sqrt{\mu+\operatorname{Re}(\gamma)}} \right|. \tag{97}$$

Fix $\sigma > 0$. For B sufficiently large there exist some μ and $\overline{\mu} < \mu$ that

$$\left| \frac{A}{2\sqrt{B} - \mu\sqrt{\mu - \overline{\mu}}} \right| < \sigma. \tag{98}$$

For $Re(\gamma) > -\overline{\mu}$ we have

$$\left| \frac{A}{B+\gamma} \right| \le \left| \frac{A}{2\sqrt{B-\mu}\sqrt{\mu + \operatorname{Re}(\gamma)}} \right| \le \left| \frac{A}{2\sqrt{B-\mu}\sqrt{\mu - \overline{\mu}}} \right| < \sigma.$$
(99)

In consequence for α^i and λ_0^i sufficiently large, we can find that $\overline{\mu} > 0$ such that the modulus of the right-hand side of (68) is less than 1 for every γ , for which $\text{Re}(\gamma) > -\overline{\mu}$.
