# ON THE NUMBER OF REPRESENTATIONS OF POSITIVE INTEGERS BY QUADRATIC FORMS AS THE BASIS OF THE SPACE $S_{4}\left(\Gamma_{0}(47), 1\right)$

#### Abstract

The number of representations of positive integers by quadratic forms $F_{1}=x_{1}^{2}+x_{1} x_{2}+$ $12 x_{2}^{2}$ and $G_{1}=3 x_{1}^{2}+x_{1} x_{2}+4 x_{2}^{2}$ of discriminant -47 are given. Moreover, a basis for the space $S_{4}\left(\Gamma_{0}(47), 1\right)$ are constructed, and the formulas for $r\left(n ; F_{4}\right), r\left(n ; G_{4}\right), r\left(n ; F_{3} \oplus G_{1}\right)$, $r\left(n ; F_{2} \oplus G_{2}\right)$, and $r\left(n ; F_{1} \oplus G_{3}\right)$ are derived.

1. Introduction. A real binary quadratic form $F$ is a polynomial in two variables $x_{1}$ and $x_{2}$ of the shape $F=F\left(x_{1}, x_{2}\right)=a x_{1}^{2}+b x_{1} x_{2}+c x_{2}^{2}$ with real coefficients $a, b, c$. The discriminant of $F$ is defined by the formula $b^{2}-4 a c$ and is denoted by $\Delta(F)$, where $F$ is an integral form if and only if $a, b, c \in \mathbb{Z}$, and is positive definite if and only if $\Delta(F)<0$ and $a, c>0$. If $\operatorname{gcd}(a, b, c)=1$, then $F$ is called primitive.

Let $F_{1}=a x_{1}^{2}+b x_{1} x_{2}+c x_{2}^{2}$ and $G_{1}=d x_{1}^{2}+e x_{1} x_{2}+f x_{2}^{2}$ be two positive definite quadratic forms with discriminant $\Delta\left(F_{1}\right)$ and $\Delta\left(G_{1}\right)$, respectively. For each $k \geqslant 1$, let $F_{k}$ and $G_{k}$ denote the direct sum of $k$-copies of $F_{1}$ and $G_{1}$, respectively, where $F_{1}$ and $G_{1}$ have two variables, $F_{2}$ and $G_{2}$ have four variables, and therefore $F_{k}$ and $G_{k}$ have $2 k$ variables.

Let

be a positive definite quadratic form of discriminant $\Delta$ in $k$ ( $k$ is even) variables with integral coefficients $b_{r s}$. Consider the quadratic form

of discriminant $\check{D}$. Then $\Delta=(-1)^{k / 2} \check{D}$. Let $A_{r s}$ be the algebraic cofactors of elements $a_{r s}$ in $\check{D}$, let $\delta=\operatorname{gcd}\left(A_{r r} / 2, A_{r s}\right),(r, s=1,2, \ldots, k)$, let $N=\check{D} / \delta$ be the level of the form $Q$, and let $\chi(d)$ be the character of the form $Q$, that is, $\chi(d)=1$ if $\Delta$ is a perfect square, but if $\Delta$ is not a perfect square and $2 \nmid \Delta$, then $\chi(d)=(d /|\Delta|)$ for $d>0$ and $\chi(d)=(-1)^{k / 2} \chi(-d)$ for $d<0$, where $(d /|\Delta|)$ is the generalized Jacobi symbol.

A positive definite quadratic from in $k$ variables of level $N$ and character $\chi(d)$ is called a quadratic form of type $(-k / 2, N, \chi)$. Let $P_{v}=P_{v}\left(x_{1}, x_{2}, \ldots, x_{k}\right)$ be the spherical function of order $v$ with respect to the quadratic form $Q$. Furthermore, let $q$ denote an odd prime number.

Let $\Gamma$ (1) denote a full modular group and let $\Gamma$ denote any subgroup of a finite index in $\Gamma(1)$. In particular,

for $N \in \mathbb{N}$.
Let $G_{k}(\Gamma, \chi)$ and $S_{k}(\Gamma, \chi)$ denote the space of entire modular and cusp forms, respectively, of type ( $k, \Gamma, \chi$ ). If $F(\tau) \in G_{k}(\Gamma, \chi)$, then in the neighbourhood of the cusps $\zeta=i \infty ;$

The order of an entire modular form $F(\boldsymbol{\tau}) \neq 0$ of type $(k, \Gamma, \chi)$ at the cusps $\zeta=i \infty$ with respect to $\Gamma$ is

where $Q(X)=1 / 2, \sum_{r, s=1}^{k} a_{r s} x_{r} x_{s}$ is a quadratic form of type $(k / 2, N, \chi), P_{v}(X)$ is a spherical function of order $v$ with respect to the $Q(X), n_{1}, \ldots, n_{k}$ are integers, and $h=\left(h_{1}, \ldots, h_{k}\right)$, where $h_{i}$ are integers such that

As well known, to each positive definite quadratic form $Q$, there corresponds the theta series

where $r(n ; Q)$ is the number of representations of a positive integer $n$ by the quadratic form $Q$.

Lemma 1.1. Any positive definite quadratic form $Q$ of type $(-k, q, 1), k>2$, corresponds to one and the same Eisenstein series

$\zeta(k)$ is the zeta function of Riemann, and $\sigma_{k-1}(n)=\sum_{d \mid n} d^{k-1}[1]$.
Lemma 1.2. If $Q$ is a primitive quadratic form of type $(-k, q, 1), 2 \mid k$, then the difference $\wp(\tau ; Q)-E(\tau ; Q)$ is a cusp form of type $(-k, q, 1)[1]$.

Lemma 1.3. The homogeneous quadratic polynomials in $k$ variables

are spherical functions of second order with respect to the positive definite quadratic form $Q$ in $k$ variables [1].

Lemma 1.4. If $Q$ is a quadratic form of type $(-k / 2, N, \chi)$ and $P_{v}$ is the spherical function of order $v$ with respect to $Q$, then the generalized theta series

is a cusp form of type $(-(k / 2+v), N, \chi)[1]$.
Lemma 1.5. If $Q_{1}$ and $Q_{2}$ are quadratic forms of types $\left(k_{1}, N, \chi_{1}\right)$ and $\left(k_{2}, N, \chi_{2}\right)$, respectively, then the quadratic form $Q_{1} \oplus Q_{2}$, direct sum of $Q_{1}$ and $Q_{2}$, is a quadratic form of type $\left(k_{1}+k_{2}, N, \chi_{1} \chi_{2}\right)$ [1].

Lemma 1.6. If $Q$ is a quadratic form of type ( $k, N, \chi$ ), then

2. The number of representations of positive integers by quadratic forms. In this note, we consider the quadratic forms $F_{1}=x_{1}^{2}+x_{1} x_{2}+12 x_{2}^{2}$ and $G_{1}=3 x_{1}^{2}+x_{1} x_{2}+$ $4 x_{2}^{2}$ of discriminant -47 . Firstly, we investigate which positive integers can be represented by $F_{1}, G_{1}, F_{2}, G_{2}$, or $F_{1} \oplus G_{1}$, and then we construct a basis for the cusp space
$S_{4}\left(\Gamma_{0}(47), \chi\right)$. Moreover, we derive the formulas for $r\left(n ; F_{4}\right), r\left(n ; G_{4}\right), r\left(n ; F_{3} \oplus G_{1}\right)$, $r\left(n ; F_{2} \oplus G_{2}\right)$, and $r\left(n ; F_{1} \oplus G_{3}\right)$.

For the quadratic form $F_{1}=x_{1}^{2}+x_{1} x_{2}+12 x_{2}^{2}, b_{11}=1, b_{12}=b_{21}=1 / 2$, and $b_{22}=12$. Therefore, $a_{11}=2, a_{12}=a_{21}=1 / 2$, and $a_{22}=24$. Thus, $A_{11}=24$ and $A_{22}=2$. Here, $\check{D}=47$ since $\Delta=(-1) \check{D}$. Also $\delta=1$ and $N=\check{D} / \delta$. Therefore, $F_{1}$ is a quadratic form of type $\left(-1, \Gamma_{0}(47), \chi\right)$. Similarly, for the quadratic form $G_{1}=3 x_{1}^{2}+x_{1} x_{2}+4 x_{2}^{2}, b_{11}=3$, $b_{12}=b_{21}=1 / 2$, and $b_{22}=4$. Therefore $a_{11}=6, a_{12}=a_{21}=1 / 2$, and $a_{22}=8$. Thus $A_{11}=8$ and $A_{22}=6$. For $\check{D}=47$, since $\Delta=(-1) \check{D}, \delta=1$, and $N=47$, therefore, $G_{1}$ is a quadratic form of type ( $\left.-1, \Gamma_{0}(47), \chi\right)$.

Let $n$ be a positive integer. Then the equation

(1) has two integral solutions $(-1,0)$ and $(1,0)$ for $n=1$;
(2) has no integral solution for $n=2,3$, and 5 ;
(3) has two integral solutions $(-2,0)$ and $(2,0)$ for $n=4$.

Hence according to (1.8), we have

From (2.2), we get

Similarly, the equation

(1) has no integral solution for $n=1,2$ and 5 ;
(2) has two integral solution $(-1,0)$ and $(1,0)$ for $n=3$;
(3) has two integral solutions $(0,1)$ and $(0,-1)$ for $n=4$.

Hence according to (1.8), we have

From (2.5), we get

From (2.2) and (2.5), we have

Moreover, we get

\wp\left(\tau ; G_{3}\right)=1+6 z^{3}+6 z^{4}+\cdots ; \\
\wp\left(\tau ; G_{4}\right)=1+8 z^{3}+8 z^{4}+\cdots ;  \tag{2.8}\\
\wp\left(\tau ; F_{1} \oplus G_{3}\right)=1+2 z+6 z^{3}+20 z^{4}+12 z^{5}+\cdots ; \\
\wp\left(\tau ; F_{2} \oplus G_{2}\right)=1+4 z+4 z^{2}+4 z^{3}+24 z^{4}+40 z^{5}+\cdots ; \\
\wp\left(\tau ; F_{3} \oplus G_{1}\right)=1+6 z+12 z^{2}+10 z^{3}+20 z^{4}+60 z^{5}+\cdots .

Now consider the quadratic forms $F_{2}, G_{2}$, and $F_{1} \oplus G_{1}$. From Lemma 1.5, they are of type ( $\left.-2, \Gamma_{0}(47), 1\right)$.

THEOREM 2.1. For the quadratic form $F_{2}$,
(1) $\varphi_{11}=x_{1}^{2}-(12 / 47) F_{2}$ is a spherical function of second order with respect to $F_{2}$;
(2) $\wp\left(\tau ; F_{2}, \varphi_{11}\right)=(1 / 47)\left(46 z+116 z^{2}+184 z^{4}+460 z^{5}+\cdots\right) \in S_{4}\left(\Gamma_{0}(47), 1\right)$;
(3) $\operatorname{ord}\left(\wp\left(\tau ; F_{2}, \varphi_{11}\right), i \infty, \Gamma_{0}(47)\right)=1$.

Proof. If we take $k=4, Q=F_{2}$, and $r=s=1$, then from Lemma 1.3 we have $\varphi_{11}=x_{1}^{2}-(12 / 47) F_{2}$, which is a spherical function of second order with respect to $F_{2}$. The equation

(1) has four integral solutions $( \pm 1,0,0,0)$ and $(0,0, \pm 1,0)$ for $n=1$;
(2) has four integral solutions $(1,0, \pm 1,0)$ and $(-1,0, \pm 1,0)$ for $n=2$;
(3) has no integral solutions for $n=3$;
(4) has four integral solutions $( \pm 2,0,0,0)$ and $(0,0, \pm 2,0)$ for $n=4$;
(5) has eight integral solutions $(-2,0, \pm 1,0),(-1,0, \pm 2,0),(1,0, \pm 2,0)$, and $(2,0, \pm 1$, 0 ) for $n=5$.
So we have from Lemma 1.4,

= & \frac{46}{47} z+\frac{116}{47} z^{2}+\frac{184}{47} z^{4}+\frac{460}{47} z^{5}+\cdots \in S_{4}\left(\Gamma_{0}(47), 1\right) .

From (1.5) we have $\operatorname{ord}\left(\wp\left(\tau ; F_{2}, \varphi_{11}\right), i \infty, \Gamma_{0}(47)\right)=1$.
THEOREM 2.2. For the quadratic form $G_{2}$,
(1) $\varphi_{11}=x_{1}^{2}-(4 / 47) G_{2}$ and $\varphi_{22}=x_{2}^{2}-(3 / 47) G_{2}$ are spherical functions of second order with respect to $G_{2}$;
(2) $\wp\left(\tau ; G_{2}, \varphi_{11}\right)=(1 / 47)\left(46 z^{3}-64 z^{4}+\cdots\right) \in S_{4}\left(\Gamma_{0}(47), 1\right)$;
(3) $\wp\left(\tau ; G_{2}, \varphi_{22}\right)=(1 / 47)\left(-36 z^{3}+46 z^{4}+\cdots\right) \in S_{4}\left(\Gamma_{0}(47), 1\right)$;
(4) $\operatorname{ord}\left(\wp\left(\tau ; G_{2}, \varphi_{11}\right), i \infty, \Gamma_{0}(47)\right)=\operatorname{ord}\left(\wp\left(\tau ; G_{2}, \varphi_{22}\right), i \infty, \Gamma_{0}(47)\right)=3$.

Proof. Similarly, if we take $k=4, Q=G_{2}, r=s=1$, and $r=s=2$, then from Lemma 1.3 we have $\varphi_{11}=x_{1}^{2}-(4 / 47) G_{2}$ and $\varphi_{22}=x_{2}^{2}-(3 / 47) G_{2}$, which are spherical functions of second order with respect to $G_{2}$. The equation

\end{equation*}

(1) has no integral solutions for $n=1,2$ and 5 ;
(2) has four integral solutions $( \pm 1,0,0,0)$ and $(0,0, \pm 1,0)$ for $n=3$;
(3) has four integral solutions $(0, \pm 1,0,0)$ and $(0,0,0, \pm 1)$ for $n=4$.

So we have from Lemma 1.4,

& =\frac{46}{47} z^{3}-\frac{64}{47} z^{4}+\cdots \in S_{4}\left(\Gamma_{0}(47), 1\right),  \tag{2.12}\\
\wp\left(\tau ; G_{2}, \varphi_{22}\right) & =\frac{1}{47}\left\{(47.0 .4-3.3 .4) z^{3}+(47.1 .2-3.4 .4) z^{4}+\cdots\right\} \\
& =-\frac{36}{47} z^{3}+\frac{46}{47} z^{4}+\cdots \in S_{4}\left(\Gamma_{0}(47), 1\right) .

By definition $\operatorname{ord}\left(\wp\left(\tau ; G_{2}, \varphi_{11}\right), i \infty, \Gamma_{0}(47)\right)=\operatorname{ord}\left(\wp\left(\tau ; G_{2}, \varphi_{22}\right), i \infty, \Gamma_{0}(47)\right)=3$.
Theorem 2.3. For the quadratic form $F_{1} \oplus G_{1}$,
(1) $\varphi_{11}=x_{1}^{2}-(12 / 47)\left(F_{1} \oplus G_{1}\right)$ and $\varphi_{22}=x_{2}^{2}-(1 / 47)\left(F_{1} \oplus G_{1}\right)$ are spherical functions of second order with respect to $F_{1} \oplus G_{1}$;
(2) $\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right)=(1 / 47)\left(70 z-72 z^{3}+274 z^{4}-52 z^{5}+\cdots\right) \in S_{4}\left(\Gamma_{0}(47), 1\right)$;
(3) $\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right)=(1 / 47)\left(-2 z-6 z^{3}-32 z^{4}-20 z^{5}+\cdots\right) \in S_{4}\left(\Gamma_{0}(47), 1\right)$;
(4) $\operatorname{ord}\left(\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right), i \infty, \Gamma_{0}(47)\right)=\operatorname{ord}\left(\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right), i \infty, \Gamma_{0}(47)\right)=1$.

Proof. If we take $k=4, Q=F_{1} \oplus G_{1}, r=s=1$, and $r=s=2$, then from Lemma 1.3 we have $\varphi_{11}=x_{1}^{2}-(12 / 47) F_{1} \oplus G_{1}$ and $\varphi_{22}=x_{2}^{2}-(1 / 47) F_{1} \oplus G_{1}$, which are spherical functions of second order with respect to $F_{1} \oplus G_{1}$. The equation

(1) has two integral solutions $( \pm 1,0,0,0)$ for $n=1$;
(2) has no integral solutions for $n=2$;
(3) has two integral solutions $(0,0, \pm 1,0)$ for $n=3$;
(4) has eight integral solutions $( \pm 2,0,0,0),(1,0, \pm 1,0),(0,0,0, \pm 1)$, and $(-1,0, \pm 1,0)$ for $n=4$;
(5) has four integral solutions $(1,0,0, \pm 1)$ and $(-1,0,0, \pm 1)$ for $n=5$.

So we have

& \wp(\tau ;\left.F_{1} \oplus G_{1}, \varphi_{11}\right) \\
&= \frac{1}{47}\left\{(47.1 .2-12.1 .2) z+(47.0 .2-12.3 .2) z^{3}+(47.4 .2+47.1 .6-12.4 .8) z^{4}\right. \\
&\left.\quad+(47.1 .4-12.5 .4) z^{5}+\cdots\right\}  \tag{2.14}\\
&= \frac{70}{47} z-\frac{72}{47} z^{3}+\frac{274}{47} z^{4}-\frac{52}{47} z^{5}+\cdots \in S_{4}\left(\Gamma_{0}(47), 1\right), \\
& \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right) \\
&= \frac{1}{47}\left\{(47.0 .2-1.1 .2) z+(47.0 .2-1.3 .2) z^{3}+(47.0 .8-1.4 .8) z^{4}\right. \\
&\left.\quad+(47.0 .4-1.5 .4) z^{5}+\cdots\right\}  \tag{2.15}\\
&=-\frac{2}{47} z-\frac{6}{47} z^{3}-\frac{32}{47} z^{4}-\frac{20}{47} z^{5}+\cdots \in S_{4}\left(\Gamma_{0}(47), 1\right) .
\end{align*}

From (1.5), $\operatorname{ord}\left(\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right), i \infty, \Gamma_{0}(47)\right)=\operatorname{ord}\left(\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right), i \infty, \Gamma_{0}(47)\right)=1$.

The system of theta series in (2.10), (2.12), (2.14), and (2.15) are linearly independent since the fifth order determinant of the coefficients in the expansions of these theta series is different from zero. Since $\left|S_{4}\left(\Gamma_{0}(47), 1\right)\right|=5$, we proved Theorem 2.4.

Theorem 2.4. The system of generalized fourfold theta series

\wp\left(\tau ; G_{2}, \varphi_{22}\right)=\frac{1}{47} \sum_{n=1}^{\infty}\left(\sum_{G_{2}=n} 47 x_{2}^{2}-3 n\right) z^{n},  \tag{2.16}\\
\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right)=\frac{1}{47} \sum_{n=1}^{\infty}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{1}^{2}-12 n\right) z^{n}, \\
\wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right)=\frac{1}{47} \sum_{n=1}^{\infty}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{2}^{2}-n\right) z^{n}
\end{gather*}

is a basis of the space $S_{4}\left(\Gamma_{0}(47), 1\right)$, of cusp forms of type $\left(-4, \Gamma_{0}(47), 1\right)$.
From Theorems 2.1, 2.2, and 2.3 we have following corollaries.
Corollary 2.5. Let $F_{k}\left(G_{k}\right)$ be the direct sum of $k$-copies of $F_{1}\left(G_{1}\right)$ of type $\left(-k, \Gamma_{0}(47)\right.$, 1) and let $\varphi_{r s}$ be the spherical function of second order with respect to $F_{k}\left(G_{k}\right)$, then
(1) $\operatorname{ord}\left(\wp\left(\tau ; F_{k}, \varphi_{r s}\right), i \infty, \Gamma_{0}(47)\right)=1$;
(2) $\operatorname{ord}\left(\wp \mathfrak{}\left(\tau ; G_{k}, \varphi_{r s}\right), i \infty, \Gamma_{0}(47)\right)=3$.

Corollary 2.6. Let $F_{i} \oplus G_{j}, i, j \geqslant 1, i+j=k$ be the direct sum of $i$-copies of $F_{1}$ and $j$-copies of $G_{1}$ of type $\left(-k, \Gamma_{0}(47), 1\right)$ and let $\varphi_{r s}$ be the spherical function of second order with respect to $F_{i} \oplus G_{j}$, then

\operatorname{ord}\left(\wp\left(\tau ; F_{i} \oplus G_{j}, \varphi_{r s}\right), i \infty, \Gamma_{0}(47)\right)=1 \tag{2.17}
\end{equation*}
$$

Now we give the formulas for $r\left(n ; F_{4}\right), r\left(n ; G_{4}\right), r\left(n ; F_{3} \oplus G_{1}\right), r\left(n ; F_{2} \oplus G_{2}\right)$, and $r\left(n ; F_{1} \oplus G_{3}\right)$ by the following theorem.

THEOREM 2.7. For the quadratic forms $F_{4}, G_{4}, F_{3} \oplus G_{1}, F_{2} \oplus G_{2}$ and $F_{1} \oplus G_{3}$ we have the following formulas:

& +\frac{17864}{29.47 .221}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{1}^{2}-12 n\right)+\frac{811736}{29.47 .221}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{2}^{2}-n\right), \\
& r\left(n ; G_{4}\right)=\frac{24}{221} \sigma_{3}^{*}(n)-\frac{54}{29.221}\left(\sum_{F_{2}=n} 47 x_{1}^{2}-12 n\right) \\
& -\frac{1305584}{29.47 .221}\left(\sum_{G_{2}=n} 47 x_{1}^{2}-4 n\right)-\frac{1742266}{29.47 .221}\left(\sum_{G_{2}=n} 47 x_{2}^{2}-3 n\right) \\
& +\frac{5046}{29.47 .221}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{1}^{2}-12 n\right)+\frac{134592}{29.47 .221}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{2}^{2}-n\right) \text {, } \\

& -\frac{302460}{29.47 .221}\left(\sum_{G_{2}=n} 47 x_{1}^{2}-4 n\right)-\frac{418656}{29.47 .221}\left(\sum_{G_{2}=n} 47 x_{2}^{2}-3 n\right) \\
& +\frac{8250}{29.47 .221}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{1}^{2}-12 n\right)-\frac{54491}{29.47 .221}\left(\sum_{F_{1} \oplus G_{1}=n} 47 x_{2}^{2}-n\right), \tag{2.18}

\sigma_{3}^{*}(n)= \begin{cases}\sigma_{3}(n) & \text { if } 47 \nmid n  \tag{2.19}\\ \sigma_{3}(n)+47^{2} \sigma_{3}\left(\frac{n}{47}\right) & \text { if } 47 \mid n\end{cases}
$$

Proof. By Lemma 1.5, $F_{4}, G_{4}, F_{3} \oplus G_{1}, F_{2} \oplus G_{2}, F_{1} \oplus G_{3}$ are quadratic forms of type $\left(-4, \Gamma_{0}(47), 1\right)$. We know from Lemma 1.1 that there exist Eisenstein series which correspond to each other. For $k=4$, we have $\alpha=24 / 221$ for $\rho_{4}=1 / 240$. Thus we get

& =1+\sum_{n=1}^{\infty}\left(\alpha \sigma_{3}(n) z^{n}+\beta \sigma_{3}(n) z^{q n}\right)  \tag{2.20}\\
& =1+\frac{24}{221} z+\frac{24.9}{221} z^{2}+\frac{24.28}{221} z^{3}+\frac{24.73}{221} z^{4}+\frac{24.126}{221} z^{5}+\cdots .
\end{align*}
$$

By Lemma 1.2, the difference $\mathfrak{\wp}\left(\tau ; F_{4}\right)-E\left(\tau ; F_{4}\right)$ is a cusp form of type $\left(-4, \Gamma_{0}(47), 1\right)$. On the other hand from Theorem 2.4, $\mathfrak{\wp}\left(\tau ; F_{2}, \varphi_{11}\right), \wp\left(\tau ; G_{2}, \varphi_{11}\right), \wp\left(\tau ; G_{2}, \varphi_{22}\right), \wp\left(\tau ; F_{1} \oplus\right.$ $\left.G_{1}, \varphi_{11}\right), \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right)$ are bases of the cusp space $S_{4}\left(\Gamma_{0}(47), 1\right)$. Therefore, we can find integers $c_{1}, \ldots, c_{5}$ such that

& +c_{4} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right)+c_{5} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right) . \tag{2.21}
\end{align*}
$$

From (2.8) and (2.20), we have

\wp\left(\tau ; F_{4}\right)-E\left(\tau ; F_{4}\right)=\frac{1744}{221} z+\frac{5088}{221} z^{2}+\frac{6400}{221} z^{3}+\frac{3552}{221} z^{4}+\frac{7584}{221} z^{5}+\cdots . \tag{2.22}
\end{equation*}
$$

From (2.21) and (2.22), we get

\wp\left(\tau ; F_{4}\right)= & E\left(\tau ; F_{4}\right)+\frac{1272}{29.221} \wp\left(\tau ; F_{2}, \varphi_{11}\right)-\frac{6498200}{29.221} \wp\left(\tau ; G_{2}, \varphi_{11}\right) \\
& -\frac{8716584}{29.221} \wp\left(\tau ; G_{2}, \varphi_{22}\right)+\frac{17864}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right)  \tag{2.23}\\
& +\frac{811736}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right) .
\end{align*}
$$

Similarly, we obtain

& -\frac{1742266}{29.221} \wp\left(\tau ; G_{2}, \varphi_{22}\right)+\frac{5046}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right) \\
& +\frac{134592}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right), \\
\wp\left(\tau ; F_{3} \oplus G_{1}\right)= & E\left(\tau ; F_{3} \oplus G_{1}\right)+\frac{609}{29.221} \wp\left(\tau ; F_{2}, \varphi_{11}\right)+\frac{372911}{29.221} \wp\left(\tau ; G_{2}, \varphi_{11}\right) \\
& +\frac{416904}{29.221} \wp\left(\tau ; G_{2}, \varphi_{22}\right)+\frac{5046}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right) \\
& -\frac{52374}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right),  \tag{2.24}\\
\wp\left(\tau ; F_{2} \oplus G_{2}\right)= & E\left(\tau ; F_{2} \oplus G_{2}\right)+\frac{167}{29.221} \wp\left(\tau ; F_{2}, \varphi_{11}\right)+\frac{1193705}{29.221} \wp\left(\tau ; G_{2}, \varphi_{11}\right) \\
& +\frac{1545330}{29.221} \wp\left(\tau ; G_{2}, \varphi_{22}\right)+\frac{5046}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right) \\
& -\frac{228953}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right), \\
\wp\left(\tau ; F_{1} \oplus G_{3}\right)= & E\left(\tau ; F_{1} \oplus G_{3}\right)-\frac{54}{29.221} \wp\left(\tau ; F_{2}, \varphi_{11}\right)-\frac{302460}{29.221} \wp\left(\tau ; G_{2}, \varphi_{11}\right) \\
& -\frac{418656}{29.221} \wp\left(\tau ; G_{2}, \varphi_{22}\right)+\frac{8250}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{11}\right) \\
& -\frac{54491}{29.221} \wp\left(\tau ; F_{1} \oplus G_{1}, \varphi_{22}\right)
\end{align*}
