# NOTE ON DECIPHERABILITY OF THREE-WORD CODES

#### Abstract

The theory of uniquely decipherable (UD) codes has been widely developed in connection with automata theory, combinatorics on words, formal languages, and monoid theory. Recently, the concepts of multiset decipherable (MSD) and set decipherable (SD) codes were developed to handle some special problems in the transmission of information. Unique decipherability is a vital requirement in a wide range of coding applications where distinct sequences of code words carry different information. However, in several applications, it is necessary or desirable to communicate a description of a sequence of events where the information of interest is the set of possible events, including multiplicity, but where the order of occurrences is irrelevant. Suitable codes for these communication purposes need not possess the UD property, but the weaker MSD property. In other applications, the information of interest may be the presence or absence of possible events. The SD property is adequate for such codes. Lempel (1986) showed that the UD and MSD properties coincide for two-word codes and conjectured that every three-word MSD code is a UD code. Guzmán (1995) showed that the UD, MSD, and SD properties coincide for two-word codes and conjectured that these properties coincide for three-word codes. In an earlier paper (2001), Blanchet-Sadri answered both conjectures positively for all three-word codes $\left\{c_{1}, c_{2}, c_{3}\right\}$ satisfying $\left|c_{1}\right|=\left|c_{2}\right| \leq\left|c_{3}\right|$. In this note, we answer both conjectures positively for other special three-word codes. Our procedures are based on techniques related to dominoes.

1. Introduction. Let $A$ be a nonempty finite set or an alphabet; $A^{*}$ denotes the set of all sequences of finite length (greater than or equal to 0 ) of elements of $A$ (such sequences are called words on $A$ ). The unique sequence of length 0 , denoted by $\epsilon$, is called the empty word. $A$ code $C$ on $A$ is a nonempty finite subset of $A^{+}=A^{*} \backslash\{\epsilon\}$. The words in $C$ are called code words. A message on $C$ is a word in $A^{*}$ that is a concatenation of code words. The sequence of these code words is a decoding or factorization of the message. The code $C$ is called

- uniquely decipherable, if every message on $C$ has a unique factorization into code words;
- multiset decipherable, if any two factorizations of the same message on $C$ yield the same multiset of code words;
- set decipherable, if any two factorizations of the same message on $C$ yield the same set of code words.
Every UD code is MSD, and every MSD code is SD. It has been shown that these relationships are proper. The code $C=\{0,0111110,10101,1111\}$ on $\{0,1\}$ is an example of a proper MSD code (i.e., an MSD code that is not UD). In fact, the message

on $C$ has two distinct factorizations into code words [3, 5]. The code

on $\{0,1\}$ is an example of a proper SD code (i.e., an SD code that is not MSD). The message

\end{equation*}

on $C$ has two distinct factorizations with distinct multisets of code words [3, 5]. Guzmán presents a complete list of proper MSD and proper SD four-word codes on $\{0,1\}$ with code words of length less than or equal to 7 [3]. It is decidable whether or not a code $C$ is UD [1, 5, 6, 9] (resp., MSD [5]).

For two-word codes, the UD, MSD, and SD properties coincide [3, 7]. For three-word codes, it is an open question whether or not they coincide. Lempel [7] conjectured that every three-word MSD code is a UD code, and Guzmán [3] conjectured that the UD, MSD, and SD properties coincide for three-word codes. We answered both conjectures positively for all three-word codes $\left\{c_{1}, c_{2}, c_{3}\right\}$ satisfying $\left|c_{1}\right|=\left|c_{2}\right| \leq\left|c_{3}\right|$ [2]. In this note, we give (in Section 1.1) a brief overview of Head's and Weber's domino technique [5], and give (in Section 2) an application of this approach by proving that Lempel's and Guzmán's conjectures are true for some special three-word codes.
1.1. A domino technique. Let $A$ be an alphabet and $C$ a code on $A$. The set of all prefixes of words in $C$ will be denoted by $\operatorname{Prefix}(C)$. The domino graph associated with $C$ is the directed graph $G=(V, E)$ where

and $E=E_{1} \cup E_{2} \cup E_{3} \cup E_{4}$ where

The domino function associated with $C$ is the mapping $d$ from $E$ to $\left\{\binom{u}{\epsilon}, \left.\binom{\epsilon}{u} \right\rvert\, u \in C\right\}$ defined on

- $E_{1}$ by $\left(\right.$ open, $\left.\binom{u}{\epsilon}\right) \mapsto\binom{\epsilon}{u}$ and $\left(\right.$ open, $\left.\binom{\epsilon}{u}\right) \mapsto\binom{u}{\epsilon}$,
- $E_{2}$ by $\left(\binom{u}{\epsilon}\right.$, close $) \mapsto\binom{u}{\epsilon}$ and $\binom{\epsilon}{u}$, close $) \mapsto\binom{\epsilon}{u}$,
- $E_{3}$ by $\left(\left(\begin{array}{c}u \\ \epsilon \\ \epsilon\end{array}\right),\binom{u v}{\epsilon}\right) \mapsto\binom{\epsilon}{v}$ and $\left.\binom{\epsilon}{u},\binom{\epsilon}{u v}\right) \mapsto\binom{v}{\epsilon}$,
- $E_{4}$ by $\left(\binom{u}{\epsilon},\binom{\epsilon}{v}\right) \mapsto\binom{u v}{\epsilon}$ and $\left(\binom{\epsilon}{u},\binom{v}{\epsilon}\right) \mapsto\binom{\epsilon}{u v}$.

The domino associated with an edge $e$ of $E$ is the domino $d(e)=\binom{d_{1}(e)}{d_{2}(e)}$. The function $d$ induces mappings $d_{1}$ and $d_{2}$ from $E$ to $C \cup\{\epsilon\}$ also called domino functions. If $p=e_{1} \cdots e_{m}$ is a path in $G$, the word $d\left(e_{1}\right) \cdots d\left(e_{m}\right)$ (resp., $d_{1}\left(e_{1}\right) \cdots d_{1}\left(e_{m}\right)$, $\left.d_{2}\left(e_{1}\right) \cdots d_{2}\left(e_{m}\right)\right)$ will be denoted by $d(p)$ (resp., $\left.d_{1}(p), d_{2}(p)\right)$.

A path $p$ in $G$ from open to some vertex $\binom{u}{\epsilon}$, respectively, $\binom{\epsilon}{u}$, is trying to find two factorizations of the same message on $C$ into code words beginning with distinct code words. The decodings obtained so far are $d_{1}(p)$ and $d_{2}(p)$. The word $u$ in $A^{*}$ denotes the backlog of the first (resp., second) decoding as against the second (resp., first) one.

Guzmán [4] suggested to look at the simplified domino graph and the domino function of $C$. The simplified domino graph of $C$ is a subgraph of the domino graph of $C$. Replace $E_{1}$ by $E_{1}^{\prime}=\left\{\left.\left(\right.\right.$ open, $\left.\left.\binom{\epsilon}{u}\right) \right\rvert\, u \in C\right\}, E_{2}$ by $E_{2}^{\prime}=\left\{\left.\left(\binom{u}{\epsilon}\right.\right.$, close $\left.) \right\rvert\, u \in C\right\}, V$ by $V^{\prime}$ which consists of open, close, and those vertices $v$ in $V$ such that there is a path from open to close that goes through $v$, and $E$ by $E^{\prime}$ which consists of those edges $e$ in $E$ such that there is a path from open to close going through $e$. The simplified domino graph of $C$ is denoted by $G(C)$.

The UD, MSD, and SD properties of a code $C$ can be characterized in terms of its simplified domino graph $G(C)$ and functions $d_{1}$ and $d_{2}$,

- $C$ is not UD if and only if there is a path in $G(C)$ from open to close [6].
- $C$ is not MSD if and only if there is a path $p$ in $G(C)$ from open to close such that $d_{1}(p)$ and $d_{2}(p)$ do not have the same multiset of code words [5].
- $C$ is not SD if and only if there is a path $p$ in $G(C)$ from open to close such that $d_{1}(p)$ and $d_{2}(p)$ do not have the same set of code words [3].

As an example, we consider the code $c=\left\{c_{1}, c_{2}, c_{3}, c_{4}\right\}$ on $\{0,1\}$ discussed in $[5,4]$ $\left(c_{1}=0, c_{2}=0111110, c_{3}=10101\right.$, and $\left.c_{4}=1111\right)$. The simplified domino graph and function associated with this code are shown in Figure 1.1.

Each edge $e$ is labeled by $d(e)$. The path

is from open to close showing that $C$ is not UD. However, every path $p$ from open to close is such that $d_{1}(p)$ and $d_{2}(p)$ have the same multiset of code words showing that $C$ is MSD.
1.2. Preliminary lemmas. We give some preliminary lemmas that are used in Section 2 to prove our main results.

Definition 1.1 (see Lothaire [8]). A nonempty word $u$ on an alphabet $A$ is called primitive, if $u=v^{n}$ for some nonempty word $v$ on $A$ implies that $n=1$.

Lemma 1.2 (see Lothaire [8]). Let $u$ be a nonempty word on an alphabet A. There exist a unique primitive word $v$ and a unique positive integer $n$ such that $u=v^{n}$ ( $v$, denoted by $\sqrt{u}$, is called the root of $u$ and $n$, denoted by $\exp (u)$, is called the exponent of $u$ ). Moreover, all positive powers of $u$ have the same root.

Lemma 1.3 (see Lothaire [8]). Let $C=\{u, v\}$ be a two-word on an alphabet $A$. The UD, MSD, and SD properties are equivalent to the following properties:
(1) $u v \neq v u$.
(2) $\sqrt{u} \neq \sqrt{v}$.

LemmA 1.4 (see Blanchet-Sadri [2]). Let $u, x$ be nonempty words on an alphabet $A$ and let $k$ be a positive integer. If $\left\{u x,(u x)^{k} u\right\}$ is SD , then $u x \neq x u$.

Lemma 1.5. Let $u, v, x, y$ be nonempty words on an alphabet A satisfying $u \neq v$.
(1) The equalities $v y x=y x u=x u y$ cannot hold simultaneously.
(2)The equalities $x v y=v y x=y x u$ cannot hold simultaneously.

Proof. We prove assertion (1) (assertion (2) is proved similarly). Since $y x u=x u y$, by Lemmas 1.2 and 1.3 there exist a unique primitive word $w$ and unique positive integers $k$ and $k^{\prime}$ such that $y=w^{k}$ and $x u=w^{k^{\prime}}$. Put $x=w^{\ell} z$ and $u=z^{\prime} w^{\ell^{\prime}}$ where $w$ is not a prefix of $z$ and $w$ is not a suffix of $z^{\prime}$. If $z, z^{\prime}=\epsilon$, then $u=v$, a contradiction. Otherwise, $z, z^{\prime} \neq \epsilon$ and the equality $v y x=x u y$ implies that $w=z z^{\prime}=z^{\prime} z$. Lemmas 1.2 and 1.3 imply the existence of a unique primitive word $w^{\prime}$ and unique positive integers $m$ and $m^{\prime}$ satisfying $z=\left(w^{\prime}\right)^{m}$ and $z^{\prime}=\left(w^{\prime}\right)^{m^{\prime}}$. We get $w=\left(w^{\prime}\right)^{m+m^{\prime}}$, a contradiction with the fact that $w$ is primitive.

Lemma 1.6. Let $u, v, x, y$ be nonempty words on an alphabet $A$ satisfying $u \neq v$. If the equalities $v y x=y x v=y u x$ hold simultaneously, then $u=\left(z^{\prime} z\right)^{k}, v=\left(z z^{\prime}\right)^{k}$, $x=\left(z^{\prime} z\right)^{\ell} z^{\prime}$, and $y=\left(z z^{\prime}\right)^{m} z$ for some $k>0, \ell \geq 0, m \geq 0$, and words $z, z^{\prime}$ on $A$.

Proof. Since $v y x=y x v$, by Lemmas 1.2 and 1.3 there exist a unique primitive word $w$ and unique positive integers $k$ and $k^{\prime}$ such that $v=w^{k}$ and $y x=w^{k^{\prime}}$. Put $y=w^{\ell} z$ and $x=z^{\prime} w^{\ell^{\prime}}$ where $w$ is not a prefix of $z$ and $w$ is not a suffix of $z^{\prime}$. If $z, z^{\prime}=\epsilon$, then $u=v$, a contradiction. Otherwise, $z, z^{\prime} \neq \epsilon$ and $w=z z^{\prime}$, and the equality $y x v=y u x$ implies that $u=\left(z^{\prime} z\right)^{k}$ and the result follows.

Lemma 1.7 (see Blanchet-Sadri [2]). Let $u, v, x$ be nonempty words on an alphabet A satisfying $u \neq v$. The equalities $u x=x v$ and $v x=x u$ cannot hold simultaneously.
2. Some special three-word codes. We show that the UD, MSD, and SD properties are equivalent to the special three-word codes described in Theorems 2.1, 2.2, and 2.3.

Let $C=\left\{c_{1}, c_{2}, c_{3}\right\}$ be a three-word SD code on alphabet $A$ satisfying $\left|c_{1}\right|<\left|c_{2}\right|<$ $\left|c_{3}\right|$. Let $c_{2}$ and $c_{3}$ be written, respectively, as $c_{1}^{k} u$ and $c_{1}^{k} v$ where $c_{1}$ is not a prefix
of $u, c_{1}$ is not a prefix of $v, u$ is not a prefix of $v, k>0$, and $u, v \neq \epsilon$. For each of our theorems, we need only to show that $C$ is UD. It is easy to see that $\left\{c_{1}, c_{2}\right\}$, $\left\{c_{1}, c_{3}\right\}$, and $\left\{c_{2}, c_{3}\right\}$ are two-word SD codes, and are therefore MSD and UD codes by Lemma 1.3. When constructing $G(C)$, we see that $E_{1}^{\prime}$ consists of the edges (open, $\binom{\epsilon}{c_{i}}$ ) and $E_{2}^{\prime}$ consists of the edges $\left(\binom{c_{i}}{\epsilon}\right.$, close $)$. No $E_{3}$ - nor $E_{4}$-edge leaves $\binom{\epsilon}{c_{2}}$ and no $E_{3}$ nor $E_{4}$-edge leaves $\binom{\epsilon}{c_{3}}$.
Let $u_{i}$ (resp., $v_{i}, w_{i}$ ) be the prefix of length $i$ of $c_{1}$ (resp., $c_{2}, c_{3}$ ). We write $c_{1}=u_{i} x_{i}$. When trying to build a path from open to close, a list of vertices gets generated. The vertices are among $\binom{u_{i}}{\epsilon},\binom{v_{i}}{\epsilon},\binom{w_{i}}{\epsilon},\binom{\epsilon}{u_{i}},\binom{\epsilon}{v_{i}}$, and $\binom{\epsilon}{w_{i}}$ where $0<i \leq\left|c_{3}\right|$. The $E_{3}$ - or $E_{4}$-edges leaving $\binom{u_{i}}{\epsilon},\binom{v_{i}}{\epsilon},\binom{w_{i}}{\epsilon},\binom{\epsilon}{u_{i}},\binom{\epsilon}{v_{i}}$, and $\binom{\epsilon}{w_{i}}$ are easily described.

We need to check that none of the generated vertices is of the form $\binom{c_{1}}{\epsilon}$, $\binom{c_{2}}{\epsilon}$, or $\binom{c_{3}}{\epsilon}$ (otherwise there would be a path from open to close). It is obvious that $\binom{c_{1}}{\epsilon}$ is not the end vertex of any $E_{3}$-edge and $\binom{c_{3}}{\epsilon}$ is not the end vertex of any $E_{4}$-edge. If $\binom{c_{1}}{\epsilon}$ is the end vertex of an $E_{4}$-edge of the form $\left(\binom{\epsilon}{u_{i}},\binom{c_{1}}{\epsilon}\right)$ (resp., $\left.\left.\binom{\epsilon}{v_{i}},\binom{c_{1}}{\epsilon}\right),\binom{\epsilon}{w_{i}},\binom{c_{1}}{\epsilon}\right)$ ), then $c_{2}=u_{i} c_{1}$ or $c_{3}=u_{i} c_{1}$ (resp., $c_{2}=v_{i} c_{1}$ or $c_{3}=v_{i} c_{1}, c_{2}=w_{i} c_{1}$ or $c_{3}=w_{i} c_{1}$ ). Similarly, if $\binom{c_{2}}{\epsilon}$ is the end vertex of an $E_{4}$-edge of the form $\left.\binom{\epsilon}{u_{i}},\binom{c_{2}}{\epsilon}\right)$, respectively, $\left.\binom{\epsilon}{v_{i}},\binom{c_{2}}{\epsilon}\right)$, $\left(\binom{\epsilon}{w_{i}},\binom{c_{2}}{\epsilon}\right)$, then $c_{3}=u_{i} c_{2}$ (resp., $c_{3}=v_{i} c_{2}, c_{3}=w_{i} c_{2}$ ). If $\binom{c_{2}}{\epsilon}$ is the end vertex of an $E_{3}$-edge of the form $\left(\binom{u_{i}}{\epsilon},\binom{u_{i} c_{1}}{\epsilon}\right)$, respectively, $\left.\left.\binom{v_{i}}{\epsilon},\binom{v_{i} c_{1}}{\epsilon}\right),\binom{w_{i}}{\epsilon},\binom{w_{i} c_{1}}{\epsilon}\right)$, then $c_{2}=u_{i} c_{1}$ (resp., $c_{2}=v_{i} c_{1}, c_{2}=w_{i} c_{1}$ ). If $\binom{c_{3}}{\epsilon}$ is the end vertex of an $E_{3}$-edge of the form $\left(\binom{u_{i}}{\epsilon},\binom{u_{i} c_{1}}{\epsilon}\right)$ (resp., $\left.\left.\left.\binom{v_{i}}{\epsilon},\binom{v_{i} c_{1}}{\epsilon}\right),\left(\binom{w_{i}}{\epsilon},\binom{w_{i} c_{1}}{\epsilon}\right),\binom{u_{i}}{\epsilon},\binom{u_{i} c_{2}}{\epsilon}\right),\binom{v_{i}}{\epsilon},\binom{v_{i} c_{2}}{\epsilon}\right),\left(\binom{w_{i}}{\epsilon}\right.$, $\binom{w_{i} c_{2}}{\epsilon}$ ), then $c_{3}=u_{i} c_{1}$ (resp., $c_{3}=v_{i} c_{1}, c_{3}=w_{i} c_{1}, c_{3}=u_{i} c_{2}, c_{3}=v_{i} c_{2}, c_{3}=w_{i} c_{2}$ ). We need to consider the cases $c_{2}=v_{i} c_{1}, c_{3}=w_{i} c_{1}$, and $c_{3}=w_{i} c_{2}$.
For the rest of the discussion, we can assume that $u$ or $v$ is a prefix of $c_{1}$ (otherwise, it is not difficult to see that there is no path in $G(C)$ from open to close). Since $u$ is not a prefix of $v$ and $|u|<|v|, u$ and $v$ cannot be both prefixes of $c_{1}$. In either case, $|u|<\left|c_{1}\right|$. To simplify the notation, put $x_{|u|}=x$, and whenever $|v|<\left|c_{1}\right|$, put $x_{|v|}=y$.

First, assume that $v$ is a prefix of $c_{1}$. Here, $y \neq \epsilon$ and $v y \neq y v$ by Lemma 1.4. To simplify the notation, put $u_{|u|}=w$. in the case where $c_{3}=w_{i} c_{1}$, since $i=\left|c_{1}^{k-1} v\right|$, we have $w_{i}=c_{1}^{k-1} v$ and $c_{3}=c_{1}^{k-1} v c_{1}=c_{1}^{k} v$ yielding $v y=y v$, a contradiction. In the case where $c_{3}=w_{i} c_{2}$, we have $i=|v|-|u|, w_{i}=u_{i}, c_{3}=u_{i} c_{1}^{k} u=c_{1}^{k} v$, and $c_{1}=u_{i} x_{i}=v y$. Put $v=u_{i} t$ where $t \neq \epsilon$. The equality $u_{i} c_{1}^{k} u=c_{1}^{k} u_{i} t$ implies that $t=u$ and $u_{i} x_{i}=x_{i} u_{i}$. But then, $c_{1}=u_{i} x_{i}=u_{i} u y=u y u_{i}$. We then conclude that $u$ is a prefix of $c_{1}$, which is a contradiction. In the case where $c_{2}=v_{i} c_{1}$, we have $i=\left|c_{1}^{k-1} u\right|$. If $y \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}$, we get Figure 2.1.

Otherwise, put $v y=y v^{\prime}$ where $v^{\prime} \neq v\left(v^{\prime} \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}\right)$. If $u$ is not a prefix of $v^{\prime}$, then add the edge $\left(\binom{v}{\epsilon},\binom{\epsilon}{y}\right)$ to Figure 2.1. Otherwise, put $v^{\prime}=u s$ where $s \neq \epsilon$. We have $v_{i}=c_{1}^{k-1} w, c_{2}=c_{1}^{k-1} w c_{1}=c_{1}^{k} u$, and therefore $c_{1}=w x=x u=v y$. We have $v=w t$ where $t \neq \epsilon$, and therefore $w t y=t y u=y u s$ with $u \neq w$. By Lemma 1.5(1), we get $s \neq t$. Since $|s|=|t|$, we conclude that $s \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}$. Add the edges $\left(\binom{v}{\epsilon},\binom{\epsilon}{y}\right)$ and $\left(\binom{c_{1}^{k-1} \epsilon}{\epsilon},\binom{\epsilon}{y u}\right)$ to Figure 2.1.

In the rest of the note, we assume that $u$ is a prefix of $c_{1}$. Here, $x \neq \epsilon$ and $u x \neq x u$ by Lemma 1.4. In the case where $c_{2}=v_{i} c_{1}$, we have $v_{i}=c_{1}^{k-1} u$ and $c_{2}=c_{1}^{k-1} u c_{1}=c_{1}^{k} u$. We conclude that $u x=x u$, a contradiction. In the cases where $c_{3}=w_{i} c_{1}$ or $c_{3}=w_{i} c_{2}$, if $x \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}$, we get Figure 2.2.

Otherwise, put $u x=x u^{\prime}$ where $u^{\prime} \neq u\left(u^{\prime} \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}\right)$. If $u^{\prime}$ is not a prefix of $v$, then add the edge $\left(\binom{u}{\epsilon},\binom{\epsilon}{x}\right)$ to Figure 2.2. Otherwise, put $v=u^{\prime} c_{1}^{q} z$ where $c_{1}$ is not a prefix of $z$ and $q \geq 0$. Note that if $z=\epsilon$, then $c_{3}=c_{1}^{k} u^{\prime} c_{1}^{q}=c_{1}^{k-1} u c_{1}^{q+1}$ and so $c_{2} c_{1}^{q+1}=c_{1} c_{3}$, a contradiction with the fact that $C$ is SD. Note also that if $q \geq k$ and $z=u^{\prime}$, then $c_{1} c_{3}=c_{2} c_{1}^{q-k} c_{2} c_{1}$, a contradiction with the fact that $C$ is SD. It is not difficult to see that $c_{1}^{i} z \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}(0 \leq i<k)$ unless $z$ is a prefix of $c_{1}$, and $c_{1}^{k} z \in \operatorname{Prefix}(C) \backslash\{\epsilon\}$ only if $z$ is a prefix of $u$ or $v$. Whenever $z$ is a prefix of $c_{1}$, put $x_{|z|}=x_{1}$ and whenever $z$ is a prefix of $u$, put $c_{2}=c_{1}^{k} z c_{1}^{p^{\prime}} y^{\prime}$ where $p^{\prime} \geq 0$ and $c_{1}$ is not a prefix of $y^{\prime}$. In the case where $z$ is a prefix of $v$, put $c_{3}=c_{1}^{k} z c_{1}^{q^{\prime}} z^{\prime}$ where $q^{\prime} \geq 0$ and $c_{1}$ is not a prefix of $z^{\prime}$.

The following points enable us to assume that $|z|<|u|$ and $z$ is a prefix of $u$ whenever $z$ is a prefix of $c_{1}$ and $c_{3}=w_{i} c_{1}$ :

- if $|z|=|u|$, then $z=u=u^{\prime}$, a contradiction;
- if $|z|>|u|$, then put $z=u t=t^{\prime} u^{\prime}$ fore some $t, t^{\prime} \neq \epsilon$. Here, $c_{1}=u t x_{1}=t x_{1} u^{\prime}=$ $t^{\prime} u^{\prime} x_{1}$ implies that $t=t^{\prime}$. We also have $x=t x_{1}=x_{1} t$ and $c_{1}=u x_{1} t=x_{1} t u^{\prime}=$ $t u^{\prime} x_{1}$. These equalities cannot hold simultaneously by Lemma 1.5(1).
If $c_{3}=w_{i} c_{2}$ and $|z|=|u|$, we have $z=u$ and $z$ is not a prefix of $v$. In this case, if $q<k-1, u=u^{\prime}$, a contradiction, and if $q \geq k-1, C$ is not $\operatorname{SD}\left(c_{1} c_{3}=c_{2} c_{1}^{q-k+1} c_{2}\right)$. The above and the following points enable us to assume that $|z|<|u|, z$ is a prefix of $u$, and $q>k-1$ whenever $z$ is a prefix of $c_{1}$ and $c_{3}=w_{i} c_{2}$ :
- if $|z|>|u|$, then put $z=u t=t^{\prime} u$ for some $t, t^{\prime} \neq \epsilon$. Here, $c_{1}=u t x_{1}=t x_{1} u^{\prime}=$ $x_{1} u^{\prime} t^{\prime}$ and $t=t^{\prime}$. These equalities cannot hold simultaneously by Lemma 1.5(1);
- if $|z|<|u|$, then put $u=z t=t^{\prime} z$ for some $t, t^{\prime} \neq \epsilon$, and put $u^{\prime}=z^{\prime \prime} t^{\prime}$. In this case, if $q<k$, then $c_{1}^{k} u^{\prime} c_{1}^{q} z=c_{1}^{q} z c_{1}^{k} u$ and $c_{1}=z t x=t x z^{\prime \prime}=x z^{\prime \prime} t^{\prime}$ with $t=t^{\prime}$. These equalities cannot hold simultaneously by Lemma 1.5(1).
Trying to build a path from open to close, add $\left(\binom{u}{\epsilon},\binom{\epsilon}{x}\right)$ and Figure 2.3 to Figure 2.2.

The edge $\left(\binom{c_{1}^{k-1} \epsilon}{\epsilon},\left(\begin{array}{c}c_{1}^{k-1} u c_{2}\end{array}\right)\right)$ is added in case $q>k-1$, or $q=k-1$, $u$ is a proper prefix of $z$, and $z$ is not a prefix of $v$. The edge $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon}\right)$ is added in case
 proper prefix of $z$, and $z$ is not a prefix of $v$. The edge $\left(\left(\left(_{c_{1}^{k-1}}^{\epsilon} u\right),\binom{\epsilon}{c_{1}^{q+1} z}\right)\right.$ is added in case $q<k-1$ and $z$ is a prefix of $u$, or $q=k-1$ and $z$ is a prefix of $u$ or $v$. The edge $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{q-k}}{\epsilon},\binom{\epsilon}{c_{1}^{k} z}\right)$ is added in case $q>k-1$ and $z$ is a prefix of $u$ or $v$. If $i \geq 0$ and $q-k<i \leq q$, the edge $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{\epsilon_{1}^{\epsilon}-i}{c_{1}^{-i}}\right)$ is added in case $z$ is a prefix of $u$. Note that no $E_{3}$ - nor $E_{4}$-edge leaves $\binom{\epsilon}{x}$, and no $E_{3}$ - nor $E_{4}$-edge leaves the vertices in Figure 2.3 other than the edges discussed above.

In the rest of the discussion, whenever $u$ is a proper prefix of $z$, we put $z=u r$ where $r \neq \epsilon$ and $x$ is not a prefix of $r$, and whenever $u^{\prime}$ is a prefix of $z$, we put $z=u^{\prime} r^{\prime}$. It is not difficult to see that $r \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}$ (otherwise, $u r=z$ is a prefix of $u x=c_{1}$ and therefore $z$ is a prefix of $u$, a contradiction). Note the following points:

- No $E_{3}$-edge leaves ( $\left(\begin{array}{c}c_{1}^{k-1} u c_{2}\end{array}\right)$ unless $q=k$ and $u^{\prime}$ is a prefix of $z$. No $E_{4}$-edge leaves $\binom{c_{1}^{k-1} u c_{2}}{\epsilon}$ other than $\left(\binom{c_{1}^{k-1} u c_{2}}{\epsilon},\binom{\epsilon}{x z}\right)$ in case $q=k$ and $x z \in \operatorname{Prefix}(C) \backslash\{\epsilon\}$.
- No $E_{3}$ - nor $E_{4}$-edges leave $\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon}(0 \leq i<q-k-1)$.
- For $q>k$ and $i=q-k-1$, no $E_{3}$-edge leaves $\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon}$ unless $u^{\prime}$ is a prefix of $z$, and no $E_{4}$-edge leaves $\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon}$ other than $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon},\binom{\epsilon}{x z}\right)$ in case $x z \in \operatorname{Prefix}(C) \backslash\{\epsilon\}$.
- No $E_{3}$ - nor $E_{4}$-edges leave $\binom{c_{1}^{k} u^{\prime} c_{1}^{q-k}}{\epsilon}$.

We now state and prove our main results.
Theorem 2.1. Let $C, u, v$, and $z$ be defined as described above. If $z$ is a prefix of both $u$ and $v$, then $C$ is UD.

Proof. Here $|z|<|u|$. Put $u=z t$ and $u^{\prime}=z t^{\prime}$ where $t, t^{\prime} \neq \epsilon$ and $t \neq t^{\prime}$. First, assume that $c_{3}=w_{i} c_{1}$. Here $u^{\prime}=t^{\prime} z$ and $c_{1}=z t x=x z t^{\prime}=x t^{\prime} z=z x t^{\prime}=t x z$. By Lemma 1.5(2), the equalities $z t x=t x z=x z t^{\prime}$ cannot hold simultaneously. Now, assume that $c_{3}=w_{i} c_{2}$. Here $u=t^{\prime} z$ and $c_{1}=z t x=x z t^{\prime}=t^{\prime} z x=z x t^{\prime}$. Since $t^{\prime} z x=$ $z x t^{\prime}=z t x$, by Lemma 1.6, $t=\left(s^{\prime} s\right)^{\ell}, t^{\prime}=\left(s s^{\prime}\right)^{\ell}, x=\left(s^{\prime} s\right)^{m} s^{\prime}, z=\left(s s^{\prime}\right)^{n} s$ for some $\ell>0, m \geq 0, n \geq 0$, and words $s, s^{\prime}$ on $A$. The equality $z t x=x z t^{\prime}$ implies that $s s^{\prime}=s^{\prime} s$, and therefore $t=t^{\prime}$, a contradiction.

THEOREM 2.2. Let $C, u, v$, and $z$ be defined as described above. If $z$ is a prefix of $u$ but not a prefix of $v$, then $C$ is UD.

Proof. Here, $|z|<|u|$. Put $u=z t$ and $u^{\prime}=z^{\prime \prime} t^{\prime}$, where $z \neq z^{\prime \prime}$ and $t, t^{\prime} \neq \epsilon$. We have $x z \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}$ since $c_{1}=x z^{\prime \prime} t$ and $z \neq z^{\prime \prime}$.

First, assume that $c_{3}=w_{i} c_{1}$. Here $u^{\prime}=t^{\prime} z$ and $c_{1}=z t x=z x t^{\prime}=t x z=x z^{\prime \prime} t^{\prime}=$ $x t^{\prime} z$. If $t=t^{\prime}$, then $z x t=x t z=x z^{\prime \prime} t$. By Lemma 1.6, $z^{\prime \prime}=\left(s^{\prime} s\right)^{\ell}, z=\left(s s^{\prime}\right)^{\ell}, t=$ $\left(s^{\prime} s\right)^{m} s^{\prime}, x=\left(s s^{\prime}\right)^{n} s$ for some $\ell>0, m \geq 0, n \geq 0$, and words $s, s^{\prime}$ on $A$. The equality $t x z=x t z$ implies that $s s^{\prime}=s^{\prime} s$, and therefore $z=z^{\prime \prime}$, a contradiction. Otherwise, since $|t|<|u|$ and $c_{1}=t x z$, we get $u=t z^{\prime \prime \prime}$ for some $z^{\prime \prime \prime}$. We have $z x=x z^{\prime \prime}$ and $z^{\prime \prime \prime} x=x z$. Certainly $z^{\prime \prime \prime} \neq z$, and by Lemma $1.7, z^{\prime \prime \prime} \neq z^{\prime \prime}$. By Lemma 1.6 , since $z t x=$ $t x z=t z^{\prime \prime \prime} x$, put $z^{\prime \prime \prime}=\left(s^{\prime} s\right)^{\ell}, z=\left(s s^{\prime}\right)^{\ell}, x=\left(s^{\prime} s\right)^{m} s^{\prime}$, and $t=\left(s s^{\prime}\right)^{n} s$ for some $\ell>0$, $m \geq 0, n \geq 0$, and words $s, s^{\prime}$ on $A$. Whenever $m>0$, the equality $z t x=x z^{\prime \prime} t^{\prime}$ implies that $s s^{\prime}=s^{\prime} s$ and $z=z^{\prime \prime \prime}$, a contradiction. Otherwise, $x$ is a prefix of $z^{\prime \prime \prime}$ and we put $z^{\prime \prime \prime}=x y$ and $z=y x$, where $y=\left(s s^{\prime}\right)^{\ell-1} s$. Here $y$ cannot be a prefix of $z^{\prime \prime}$ or the equality $x z^{\prime \prime} t^{\prime}=z x t^{\prime}$ implies that $z=z^{\prime \prime \prime}$. Trying to build a path from open to close, the edge $\left(\binom{u}{\epsilon},\binom{\epsilon}{x}\right)$ together with Figure 2.3 are added to Figure 2.2. We now discuss the other edges added.

First, assume that $q \leq k$. Whenever $q<k$, add $\left(\binom{c_{1}^{k-1} u}{\epsilon},\binom{\epsilon}{c_{1}^{q+1} z}\right)$ to the graph and whenever $q=k$, add $\left(\left(\begin{array}{c}c_{1}^{k-1} u\end{array}\right),\binom{c_{1}^{k-1} u c_{2}}{\epsilon}\right)$. In either case, we then also add $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon}\right.$, $\left.\binom{\epsilon}{c_{1}^{q-i} z}\right)(0 \leq i \leq q),\left(\binom{\epsilon}{c_{1}^{i} z},\binom{\epsilon}{c_{1}^{i+1} z}\right)(0 \leq i<k),\left(\binom{\epsilon}{z},\binom{t x}{\epsilon}\right),\left(\binom{t x}{\epsilon},\binom{\epsilon}{z}\right),\left(\binom{\epsilon}{c_{1}^{i} z},\binom{c_{1}^{k-i} t}{\epsilon^{\epsilon}}\right)$ $(0 \leq i \leq k),\left(\binom{c_{1}^{i} t x}{\epsilon},\binom{c_{1}^{i+1} t x}{\epsilon}\right)(0 \leq i<k)$, and $\left(\binom{c_{1}^{i} t x}{\epsilon},\binom{\epsilon}{c_{1}^{k-i} y}\right)(0 \leq i \leq k)$.

Second, assume that $q>k$. Add $\left(\binom{c_{1}^{k-1} u}{\epsilon},\binom{c_{1}^{k-1} u c_{2}}{\epsilon}\right),\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon}\right)(0 \leq i<$ $q-k)$, and $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{\epsilon}{c_{1}^{q-i} z}\right)(q-k \leq i \leq q)$. Also add $\left(\binom{\epsilon}{c_{1}^{i} z},\binom{\epsilon}{c_{1}^{i+1} z}\right)(0 \leq i<k)$, $\left(\binom{\epsilon}{z},\binom{t x}{\epsilon}\right),\left(\binom{t x}{\epsilon},\binom{\epsilon}{z}\right),\left(\binom{\epsilon}{c_{1}^{i} z},\binom{c_{1}^{k-i} t}{{ }_{\epsilon}}\right)(0 \leq i \leq k),\left(\binom{c_{1}^{i} t x}{\epsilon},\binom{c_{1}^{i+1} t x}{\epsilon}\right)(0 \leq i<k)$, and $\left(\binom{c_{1}^{i} t x}{\epsilon},\binom{\epsilon}{c_{1}^{k-i} y}\right)(0 \leq i \leq k)$.

Now, assume that $c_{3}=w_{i} c_{2}$. Here $u=t^{\prime} z$ and $c_{1}=z t x=t^{\prime} z x=z x t^{\prime}=x z^{\prime \prime} t^{\prime}=$ $t^{\prime} x z^{\prime \prime}$. If $t=t^{\prime}$, then $z t x=t x z^{\prime \prime}=x z^{\prime \prime} t$ and these equalities cannot hold simultaneously by Lemma $1.5(1)$. Otherwise, $t \neq t^{\prime}$ and $t \notin \operatorname{Prefix}(C) \backslash\{\epsilon\}$. trying to build a path from open to close, the edge $\left(\binom{u}{\epsilon},\binom{\epsilon}{x}\right)$ together with Figure 2.3 are added to Figure 2.2. We now discuss the other edges added.

First, assume that $\boldsymbol{q}=k$. Add $\left(\binom{c_{1}^{k-1} u}{\epsilon},\binom{c_{1}^{k-1} u c_{2}}{\epsilon}\right)$ and $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{\epsilon}{c_{1}^{q-i} z}\right)(0 \leq i \leq \boldsymbol{q})$.
Second, assume that $q>k$. Add $\left(\binom{c_{1}^{k-1} u}{\epsilon},\binom{c_{1}^{k-1} u c_{2}}{\epsilon}\right),\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{c_{1}^{k} u^{\prime} c_{1}^{i} c_{2}}{\epsilon}\right)(0 \leq i<$ $q-k)$, and $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{i}}{\epsilon},\binom{\epsilon-i}{c_{1}^{q-i} z}\right)(q-k \leq i \leq q)$.

THEOREM 2.3. Let $C, u, v$, and $z$ be defined as described above. If $z$ is a prefix of $v$ but not a prefix of $u$, then $C$ is UD.
Proof. Here $c_{3}=c_{1}^{k} u^{\prime} c_{1}^{q} z=c_{1}^{k} z c_{1}^{q^{\prime}} z^{\prime}$ and $\left|c_{1}^{q^{\prime}} z^{\prime}\right|=\left|c_{1}^{q} u\right|$. The latter and the fact that $|u|<\left|c_{1}\right|$ imply that $q \geq q^{\prime}$. Note that $u$ is not a prefix of $z, u^{\prime}$ is a suffix of $z^{\prime}$ in case $c_{3}=w_{i} c_{1}$, and $u$ is a suffix of $z^{\prime}$ in case $c_{3}=w_{i} c_{2}$. Trying to build a path from open to close, the edge $\left(\binom{u}{\epsilon},\binom{\epsilon}{x}\right)$ together with Figure 2.3 are added to Figure 2.2. We now discuss the other edges added (if any).

First, assume that $q<k-1$. In this case, no more edges are added.
Second, assume that $q=k-1$. We have $\left|c_{1}^{q^{\prime}} z^{\prime}\right|=\left|c_{1}^{k-1} u\right|$ and add $\left(\binom{c_{1}^{k-1} u}{\epsilon},\binom{\epsilon}{c_{1}^{k}}\right)$ along with

In case $c_{3}=w_{i} c_{2}$, we have $c_{1}^{q^{\prime}} z^{\prime}=c_{1}^{k-1} u\left(q^{\prime}=k-1\right.$ and $\left.z^{\prime}=u\right)$ and also add $\left(\left(\begin{array}{c}c_{1}^{k} z c_{1}^{q^{\prime}-i}\end{array}\right),\binom{c_{1}^{i} u}{\epsilon}\right)(0 \leq i<k)$.
Third, assume that $q=k$ and $c_{3}=w_{i} c_{2}$. We have $c_{1}^{q^{\prime}} z^{\prime}=c_{1}^{k} u\left(q^{\prime}=k\right.$ and $\left.z^{\prime}=u\right)$ and $|z| \neq|u|$ here. If $|z|<|u|$, then $u^{\prime}=z t$ and $u=t z$ for some $t \neq \epsilon$. The latter together with the equality $c_{1}^{k} u^{\prime} c_{1}^{k} z=c_{1}^{k} z c_{1}^{k} u$ yield that $c_{1}=t z x=x z t=z x t$ and therefore $z$ is a prefix of $u$, a contradiction. If $|z|>|u|$, put $z=u^{\prime} c_{1}^{p} t^{\prime}=t u$ where $t^{\prime} \neq \epsilon$ and $c_{1}$ is not a prefix of $t$ nor $t^{\prime}$. To simplify the notation, whenever $\left|t^{\prime}\right|<\left|c_{1}\right|$, put $x_{\left|t^{\prime}\right|}=x^{\prime}$. From the equality $c_{1}^{k} u^{\prime} c_{1}^{k} z=c_{1}^{k} z c_{1}^{k} u$, it follows that $c_{1}^{k} u^{\prime} c_{1}^{p} t^{\prime}=c_{1}^{p} t^{\prime} c_{1}^{k} u$.

- If $p>k$, we contradict the fact that $c_{1}$ is not a prefix of $z$.
- If $p<k$, then $\left|t^{\prime}\right|<\left|c_{1}\right|$ or we contradict the fact that $c_{1}$ is not a prefix of $t^{\prime}\left(t^{\prime}\right.$ is a prefix of $c_{1}$ here). If $\left|t^{\prime}\right|<|u|$, put $u=t^{\prime} r_{1}=r_{1}^{\prime} t^{\prime}$ and $u^{\prime}=t^{\prime \prime} r_{1}^{\prime}$. We then have $c_{1}=t^{\prime} r_{1} x=r_{1}^{\prime} t^{\prime} x=x t^{\prime \prime} r_{1}^{\prime}=r_{1} x t^{\prime \prime}$ and $r_{1}=r_{1}^{\prime}$. Then $t^{\prime} \neq t^{\prime \prime}$ and we have $t^{\prime} r_{1} x=$ $r_{1} x t^{\prime \prime}=x t^{\prime \prime} r_{1}$, which cannot hold simultaneously by Lemma 1.5(1). If $\left|t^{\prime}\right|=|u|$, then $t^{\prime}=u$ and, when $k-p=1, C$ is not SD $\left(c_{1} c_{3}=c_{2}^{3}\right)$. When $k-p>1$, we get $u=u^{\prime}$, a contradiction. So we have $\left|t^{\prime}\right|>|u|$ and put $t^{\prime}=u r_{1}=r_{1}^{\prime} u$. Then $c_{1}=u r_{1} x^{\prime}=$ $r_{1}^{\prime} u x^{\prime}=r_{1} x^{\prime} u^{\prime}=x^{\prime} u^{\prime} r_{1}^{\prime}$ and $r_{1}=r_{1}^{\prime}$. Consequently, $u r_{1} x^{\prime}=r_{1} x^{\prime} u^{\prime}=x^{\prime} u^{\prime} r_{1}$, which cannot hold simultaneously by Lemma 1.5(1).
- If $p=k$ then from the equality $c_{1}^{k} u^{\prime} c_{1}^{p} t^{\prime}=c_{1}^{p} t^{\prime} c_{1}^{k} u$ it follows that $u^{\prime} c_{1}^{k} t^{\prime}=t^{\prime} c_{1}^{k} u$. Here, clearly $\left|t^{\prime}\right| \neq|u|$. If $\left|t^{\prime}\right|<|u|$, put $u^{\prime}=t^{\prime} r_{1}$ and $u=r_{1} t^{\prime}=t^{\prime \prime} r_{1}^{\prime}$ where $\left|t^{\prime}\right|=\left|t^{\prime \prime}\right|$. This then yields that $c_{1}=r_{1} t^{\prime} x=t^{\prime \prime} r_{1}^{\prime} x=x t^{\prime} r_{1}=t^{\prime} x r_{1}$ and $t^{\prime}=t^{\prime \prime}$. So we have $r_{1} \neq r_{1}^{\prime}$ and $r_{1} t^{\prime} x=t^{\prime} x r_{1}=t^{\prime} r_{1}^{\prime} x$. Using Lemma 1.6 and the fact that $t^{\prime} x r_{1}=x t^{\prime} r_{1}$, we conclude that $u=u^{\prime}$, a contradiction. Thus $\left|t^{\prime}\right|>|u|$ and put $t^{\prime}=u^{\prime} c_{1}^{p_{1}} t_{1}^{\prime}=t_{1} u$ for some $t_{1}$ and $t_{1}^{\prime}$ where $t_{1}^{\prime} \neq \epsilon$ and $c_{1}$ is not a prefix of $t_{1}$ nor $t_{1}^{\prime}$. From the equality $u^{\prime} c_{1}^{k} t^{\prime}=$ $t^{\prime} c_{1}^{k} u$, it follows that $c_{1}^{k} u^{\prime} c_{1}^{p_{1}} t_{1}^{\prime}=c_{1}^{p_{1}} t_{1}^{\prime} c_{1}^{k} u$ and we continue as above, comparing $p_{1}$ to $k$. Since $c_{3}$ is finite, we must reach $t_{i}^{\prime}=u^{\prime} c_{1}^{p_{i}+1} t_{i+1}^{\prime}=t_{i+1} u$ where $t_{i+1}^{\prime} \neq \epsilon$ and $c_{1}$ is not a prefix of $t_{i+1}$ nor $t_{i+1}^{\prime}$, and consequently we get the equality $c_{1}^{k} u^{\prime} c_{1}^{p_{i}+1} t_{i+1}^{\prime}=$ $c_{1}^{p_{i+1}} t_{i+1}^{\prime} c_{1}^{k} u$. Then we have $p_{i+1}>k, p_{i+1}<k$, or $p_{i+1}=k$, and $\left|t_{i+1}^{\prime}\right| \leq|u|$. In all cases we reach the same types of contradictions as previously stated.

Fourth, assume that $q>k$ and $c_{3}=w_{i} c_{2}$. Since $\left|c_{1}^{q} u\right|=c_{1}^{q^{\prime}} z^{\prime}$, it follows that $c_{2}$ is a suffix of $c_{1}^{q^{\prime}} z^{\prime}$ and we put $c_{3}=c_{1}^{k} u^{\prime} c_{1}^{q} z=c_{1}^{k} z c_{1}^{q^{\prime}} z^{\prime}=c_{1}^{k} z s c_{1}^{k} u$ where $|s|=\left|c_{1}^{q-k}\right|$. Clearly, $|z| \neq|u|$ here. If $|z|<|u|$, put $u^{\prime}=z t$ and $u=t z$ for some $t \neq \epsilon$. The latter together with the equality $c_{1}^{k} u^{\prime} c_{1}^{q} z=c_{1}^{k} z s c_{1}^{k} u$ yield that $c_{1}=t z x=$ $x z t=z x t$, which contradicts the fact that $z$ is not a prefix of $u$. If $|z|>|u|$,
put $z=u^{\prime} c_{1}^{p} t^{\prime}=t u$ where $t^{\prime} \neq \epsilon$ and $c_{1}$ is not a prefix of $t$ nor $t^{\prime}$. To simplify the notation, whenever $\left|t^{\prime}\right|<\left|c_{1}\right|$, put $x_{\left|t^{\prime}\right|}=x^{\prime}$. From the equality $c_{1}^{k} u^{\prime} c_{1}^{q} z=c_{1}^{k} z s c_{1}^{k} u$, it follows that $c_{1}^{q} u^{\prime} c_{1}^{p} t^{\prime}=c_{1}^{p} t^{\prime} s c_{1}^{k} u$. Here if $k-p>1$, we get $u=u^{\prime}$, a contradiction. If $k-p \leq 1$ then $C$ is not $\operatorname{SD}\left(c_{1} c_{3}=c_{2} c_{1}^{q-k} c_{2} c_{1}^{p-k+1} c_{2}\right)$. If $\left|t^{\prime}\right|<|u|$, put $u=t^{\prime} r_{1}=$ $r_{1}^{\prime} t^{\prime}$ and $u^{\prime}=t^{\prime \prime} r_{1}^{\prime}$. We then have $c_{1}=t^{\prime} r_{1} x=r_{1}^{\prime} t^{\prime} x=x t^{\prime \prime} r_{1}^{\prime}=t^{\prime} x r_{1}^{\prime}=r_{1}^{\prime} x t^{\prime \prime}$. Clearly, $\left|t^{\prime}\right| \neq|u|$, and if $\left|t^{\prime}\right|<|u|$,then put $u^{\prime}=t^{\prime} r_{1}$ and $u=r_{1} t^{\prime}=t^{\prime \prime} r_{1}^{\prime}$ where $\left|t^{\prime}\right|=$ $\left|t^{\prime \prime}\right|$. Since $c_{3}$ is finite, we must reach the equality $t_{i}^{\prime}=u^{\prime} c_{1}^{p_{i+1}} t_{i+1}^{\prime}=$ $t_{i+1}^{\prime} u$ where $t_{i+1}^{\prime} \neq \epsilon$ and $c_{1}$ is not a prefix of $t_{i+1}$ nor $t_{i+1}^{\prime}$, and consequently we get the equality $c_{1}^{q} u^{\prime} c_{1}^{p_{i+1}} t_{i+1}^{\prime}=c_{1}^{p_{i+1}} t_{i+1}^{\prime} s c_{1}^{k} u$. Then one of the following must occur:
(1) $p_{i+1}>q$, thus yielding the same type of contradiction as above;
(2) $p_{i+1}<q$ and $\left|t_{i+1}^{\prime}\right| \geq|u|$, thus yielding the same types of contradiction as above;
(3) $p_{i+1}<q,\left|t_{i+1}^{\prime}\right|<|u|$, and $p_{i+1}<k$, thus yielding the same type of contradiction as above;
(4) $p_{i+1}<q,\left|t_{i+1}^{\prime}\right|<|u|$, and $p_{i+1} \geq k$, in which case we add

Here, if $\left|t^{\prime}\right|=$ $|u|$, then $t^{\prime}=u^{\prime}$ and $C$ is not $\operatorname{SD}\left(c_{1} c_{3}=c_{2} c_{1}^{q-k} c_{2} c_{1}^{q-k} c_{2} c_{1}\right)$. If $\left|t^{\prime}\right|<|u|$ then put $u^{\prime}=$ $t^{\prime} r_{1}=r_{1} t^{\prime}$ and $u=t^{\prime \prime} r_{1}^{\prime}$, where $\left|t^{\prime}\right|=\left|t^{\prime \prime}\right|$. So we have $c_{1}=x t^{\prime} r_{1}=x r_{1} t^{\prime}=t^{\prime \prime} r_{1}^{\prime} x=$ $r_{1}^{\prime} x t^{\prime}$. If $t^{\prime}=t^{\prime \prime}$, then $r_{1} \neq r_{1}^{\prime}$ and we get $t^{\prime} r_{1}^{\prime} x=r_{1}^{\prime} x t^{\prime}=x t^{\prime} r_{1}$, which cannot hold simultaneously by Lemma 1.5(2). So we assume that $t^{\prime} \neq t^{\prime \prime}$, and if $r_{1}=r_{1}^{\prime}$ then $t^{\prime \prime} r_{1} x=$ $r_{1} x t^{\prime}=x t^{\prime} r_{1}$, which cannot hold by Lemma 1.5(1). Thus $t^{\prime} \neq t^{\prime \prime}, r_{1} \neq r_{1}^{\prime}$, and $x z=$ $x u^{\prime} c_{1}^{q} t^{\prime}=c_{1}^{q+1} t^{\prime} \notin \operatorname{prefix}(C) \backslash\{\epsilon\}$. Note that here $q^{\prime}=0$ or we contradict the fact that $r_{1} \neq r_{1}^{\prime}$. When $q=k$, we $\operatorname{add}\left(\binom{c_{1}^{k-1} u c_{2}}{\epsilon},\binom{c_{1}^{k} u^{\prime} c_{1}^{k} u^{\prime} c_{1}^{k-1} u}{\epsilon}\right)$ as well as $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{k} u^{\prime} c_{1}^{k-1} u}{\epsilon},\binom{\epsilon}{x t^{\prime}}\right)$ and $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{k} u^{\prime}}{\epsilon},\binom{\epsilon}{c_{1}^{k} t^{\prime}}\right.$. When $q>k$, add (2.1) and $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{q-k-1} c_{2}}{\epsilon},\binom{\left(c_{1}^{k} u^{\prime} c_{1}^{q} u^{\prime} c_{1}^{k-1} u\right.}{\epsilon}\right)$ along with $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{q} u^{\prime} c_{1}^{q-k-1} c_{2}}{\epsilon},\binom{\epsilon}{x t^{\prime}}\right)$ and $\left(\binom{c_{1}^{k} u^{\prime} c_{1}^{q} u^{\prime} c_{1}^{q-k}}{\epsilon},\binom{\epsilon}{c_{1}^{k} t^{\prime}}\right)$. If $\left|t^{\prime}\right|>|u|$, put $t^{\prime}=$ $u^{\prime} c_{1}^{p_{1}} t_{1}^{\prime}=t_{1} u^{\prime}$, where $c_{1}$ is not a prefix of $t_{1}$ nor $t_{1}^{\prime}$, and $t_{1}^{\prime} \neq \epsilon$ (otherwise, $c_{1} c_{3}=$ $\left.c_{1} c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{2} c_{1}^{p_{1}}=\left(c_{2} c_{1}^{q-k}\right)^{2} c_{2} c_{1}^{p_{1}+1}\right)$. From the equality $u^{\prime} c_{1}^{q} t^{\prime}=t^{\prime} s c_{1}$, it follows that $c_{1}^{q} u^{\prime} c_{1}^{p_{1}} t_{1}^{\prime}=c_{1}^{p_{1}} t_{1}^{\prime} s c_{1}$ and we continue as above, comparing $p_{1}$ to $q$. Since $c_{3}$ is finite, we must reach $t_{i}^{\prime}=u^{\prime} c_{1}^{p_{i+1}} t_{i+1}^{\prime}=t_{i+1} u^{\prime}$ where $c_{1}$ is not a prefix of $t_{i+1}$ or $t_{i+1}^{\prime}$, and $t_{i+1}^{\prime} \neq \epsilon$ (otherwise, $\left.c_{1} c_{3}=c_{1} c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{p_{i+1}}=\left(c_{2} c_{1}^{q-k}\right)^{i+2} c_{2} c_{1}^{p_{i+1}+1}\right)$, and consequently we get the equality $c_{1}^{q} u^{\prime} c_{1}^{p_{i+1}} t_{i+1}^{\prime}=c_{1}^{p_{i+1}} t_{i+1}^{\prime} s c_{1}$. Then one of the following occurs:
(1) $p_{i+1}>q$, in which case we reach the same type of contradiction as above;
(2) $p_{i+1}<q$ and $\left|t_{i+1}^{\prime}\right| \geq|u|$, in which case we reach the same type of contradictions as above;
(3) $p_{i+1}<q$ and $\left|t_{i+1}^{\prime}\right|<|u|$, in which case we put $u=t_{i+t}^{\prime} r_{i+2}=r_{i+2}^{\prime \prime} t_{i+1}^{\prime \prime \prime}$ and $u^{\prime}=r_{i+2}^{\prime} t_{i+1}^{\prime}=t_{i+1}^{\prime \prime} r_{i+2}^{\prime}$ where $\left|t_{i+1}^{\prime}\right|=\left|t_{i+1}^{\prime \prime \prime}\right|$. As above, we have $t_{i+1}^{\prime} \neq t_{i+1}^{\prime \prime}, t_{i+1}^{\prime} \neq$ $t_{i+1}^{\prime \prime \prime}, r_{i+2} \neq r_{i+2}^{\prime}$, and $x z=c_{1}^{p_{i+1}+1} t_{i+1}^{\prime} \notin \operatorname{prefix}(C) \backslash\{\epsilon\}$. Also, $q^{\prime} \leq q-p_{i+1}-1$, $\left|z^{\prime}\right|=\left|c_{1}^{q-q^{\prime}} u\right|>|u|, r_{i+2}$ is a prefix of $z^{\prime}$, and $u^{\prime}$ cannot be a prefix of $z^{\prime}$.

Add $\left(\left(\begin{array}{c}c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{j}\end{array}\right),\left(\begin{array}{c}{ }_{P_{1}}{ }_{i+1}{ }^{\epsilon-j} t_{i+1}^{\prime}\end{array}\right)\right)\left(0 \leq j \leq p_{i+1}\right)$ whenever $q=k$, or $q>k$, and $p_{i+1}<k$. Whenever $q>k$ and $p_{i+1} \geq k$, add

$$
\begin{gather*}
\left(\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+1} c_{1}^{q-k-1} c_{2}}{\epsilon},\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{k-1} u}{\epsilon},\right. \\
\left(\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{j}}{\epsilon},\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{j} c_{2}}{\epsilon}, \quad\left(0 \leq j<p_{i+1}-k\right),\right. \tag{2.5}
\end{gather*}
$$

and $\left(\left(\begin{array}{c}c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)_{\epsilon}^{i+2} c_{1}^{p}{ }^{i+1^{-j}}\end{array}\right),\binom{\epsilon}{c_{1}^{j} t_{i+1}^{\prime}}\right)(0 \leq j \leq k)$. In all cases, we also include
 $\left(\binom{r_{i+2} x}{\epsilon},\binom{\epsilon}{t_{i+1}^{\prime}}\right)$, and $\left(\binom{c_{1}^{j} r_{i+2} x}{\epsilon},\binom{c_{1}^{j+1} r_{i+2} x}{\epsilon}\right)(0 \leq j<k-1)$, In the case where $q>k$, add $\left(\binom{\epsilon}{c_{1}^{k} z c_{1}^{j}},\binom{\epsilon}{c_{1}^{k} z c_{1}^{j} c_{2}}\right)$ whenever $0 \leq j<q^{\prime}-k$, or $j=q^{\prime}-k$ and $u$ is a prefix of $z^{\prime}$. In the case where $\left|t_{i+1}^{\prime \prime \prime}\right|>|x|$, put $t_{i+1}^{\prime \prime \prime}=x s_{i+1}, t_{i+1}^{\prime}=s_{i+1} x=$ $x s_{i+1}^{\prime}$, and $t_{i+1}^{\prime \prime}=s_{i+1}^{\prime} x$ where $s_{i+1} \neq s_{i+1}^{\prime}$. Add $\left(\binom{c_{1}^{k-1} r_{i+2} x}{\epsilon},\binom{c_{1}^{k} r_{i+2} x}{\epsilon}\right)$ along with $\left(\binom{c_{1}^{j} r_{i+2} x}{\epsilon},\left(\begin{array}{c}{ }_{c_{1}^{k-j}}^{\epsilon}{ }_{s_{i+1}}\end{array}\right)\right)(0 \leq j \leq k) ;$
(4) $p_{i+1}=q$ and $\left|t_{i+1}^{\prime}\right|=|u|$, in which case we reach the same type of contradiction as above;
(5) $p_{i+1}=q$ and $\left|t_{i+1}^{\prime}\right|<|u|$, in which case, when $q=k$, we add

$$
\begin{equation*}
\left(\binom{\left(c_{1}^{k} u^{\prime}\right)^{i+1} c_{1}^{k-1} u c_{2}}{\epsilon},\binom{\left(c_{1}^{k} u^{\prime}\right)^{i+3} c_{1}^{k-1} u}{\epsilon}\right), \quad\left(\binom{\left(c_{1}^{k} u^{\prime}\right)^{i+3}}{\epsilon},\binom{\epsilon}{c_{1}^{k} t_{i+1}^{\prime}}\right) \tag{2.6}
\end{equation*}
$$

and $\left(\left(\left(c_{1}^{k} u^{\prime}\right)_{\epsilon}^{i+3} c_{1}^{k-1} u\right),\binom{\epsilon}{x t_{i+1}^{\prime}}\right)$. Whenever $q>k$, we add

$$
\begin{gather*}
\left(\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+1} c_{1}^{q-k-1} c_{2}}{\epsilon},\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{k-1} u}{\epsilon}\right) \\
\left(\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{j}}{\epsilon},\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{j} c_{2}}{\epsilon}\right), \quad(0 \leq j<q-k)  \tag{2.7}\\
\left(\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{q-k}}{\epsilon},\binom{\epsilon}{c_{1}^{k} t_{i+1}^{\prime}}\right), \quad\left(\binom{c_{1}^{k} u^{\prime}\left(c_{1}^{q} u^{\prime}\right)^{i+2} c_{1}^{q-k-1} c_{2}}{\epsilon},\binom{\epsilon}{x t_{i+1}^{\prime}}\right)
\end{gather*}
$$
